

NOTICE OF ORDER

HIGHWAYS ACT 1980

HEREFORDSHIRE COUNCIL
Bridleway CL70 (Part) Clifford; Public Path Diversion Order 2016

Notice is hereby given that the above referenced Order has been submitted to the Secretary of State for Environment, Food and Rural Affairs for determination. An Inspector will be appointed by the Secretary of State to determine the Order.

The **start date** for the above Order is **9 May 2017**.

Consideration of the Order will take the form of exchanges of statements of case and comments on statements of case.

The effect of the Order, if confirmed without modifications, will be to divert that length of Bridleway CL70 (part) in the Parish of Clifford which commences at County Road U75201 at OS Grid Reference SO 2665, 4623 (Point A on the order plan) then travelling in a generally easterly direction for approximately 116 metres along a track, then continuing in a generally east-south-easterly direction, past the farm and through fields for approximately 499 metres to OS Grid Reference SO 2719 4600 (Point B on the order plan). The total length of the existing said bridleway is approximately 615 metres.

An alternative bridleway will be created, being 3 metres in width, which commences at County Road U75201 at OS Grid Reference SO 2656, 4594 (Point C on the order plan) and travels in a generally east-north-easterly direction for approximately 20 metres and passes through a field gate to OS Grid Reference SO 2659,4595 (Point D on the order plan) then continues in a generally east-south-easterly direction for approximately 143 metres to OS Grid Reference 2671,4589 where it passes through a field gate, then continuing for a further 38 metres to OS Grid Reference SO 2675,4589 (Point E on the order plan) where it turns and continues in a generally north-north-easterly direction for approximately 99 metres to OS Grid Reference SO 2680,4598 (Point F on the order plan) where it passes through a field gate and continues in a generally easterly direction for approximately 240 metres to OS Grid Reference SO 2704, 4602 (Point G on the order plan) then continuing for approximately 155 metres to a field gate at OS Grid Reference SO 2719,4600 (Point B on the order plan). The total length of the said proposed new bridleway is approximately 695 metres. Any queries relating to this Order should be referred to

Timetable for sending in statements of case and comments

Within 2 weeks of the start date by 23 May 2017

The Order Making Authority must ensure their statement of case is received by the Secretary of State. As soon as possible after the deadline, the Secretary of State will send a copy (excluding copies of any supporting documents - these will be available to view at the Authority's offices) to everyone who has made an objection or representation, the applicant and any other person who has written to us in respect of the Order.

Within 8 weeks of the start date by 4 July 2017

Everyone who has made an objection or representation or any other written representation must ensure their statement of case is received by the Secretary of State. As soon as possible after the deadline, the Secretary of State will send full copies to the Authority. Copies (excluding copies of any supporting documents - these will be available to view at the Authority's offices) will also be sent to the applicant, every person who has made an objection or representation and any other person who has written to us in respect of the Order.

Within the same period the applicant (if applicable) must ensure their statement of case is received by the Secretary of State. As soon as possible after the deadline, Secretary of State will send a full copy to the Authority. Copies will also be sent to everyone who has made an objection or representation and any other person who has written to us in respect of the Order (excluding copies of any supporting documents - these will be available to view at the Authority's offices).

Within 14 weeks of the start date by 15 August 2017

Everyone who has made an objection or representation, the Authority, the applicant (if applicable) and anyone who has written to us in respect of the Order must ensure that their comments on any or every other statement of case is received by the Secretary of State. As soon as possible after the deadline, the Secretary of State will send copies of these comments to everyone else.

Any other person wishing to make representations in writing to the Secretary of State in respect of the above Order(s) must do so in line with the timetable set out above.

In fairness to the other parties everyone should keep to the timetable to ensure that statements of case and comments are received on time. Late documents will be returned.

PUBLIC PATH DIVERSION ORDER 2016

This Order is made by the County of Herefordshire District Council (known as "Herefordshire Council") under section 119 of the Highways Act 1980 because it appears to Herefordshire Council that in the interests of the owner and occupier of the land crossed by the bridleway described in Part 1 of the Schedule to this Order it is expedient that part of the line of the path should be diverted.

Mrs Sylvia May Mason, the said owner, has agreed to defray any compensation which becomes payable in consequence of the coming into force of this Order.

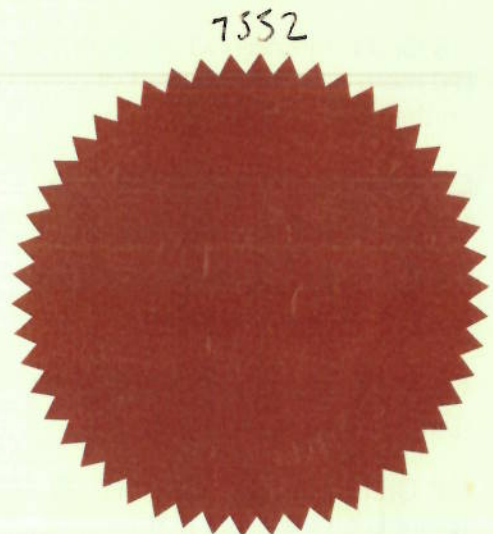
BY THIS ORDER:

1. The public right of way over the land situated at Locksters Pool Farm in the Parish of Clifford and shown by a bold continuous line on the plan contained in this Order and described in Part 1 of the said Schedule shall be stopped up in accordance with the provisions of Article 3 below.
2. There shall be created to the reasonable satisfaction of Herefordshire Council and in accordance with Article 3 below an alternative public bridleway over the land situated at Locksters Pool Farm in the Parish of Clifford described in Part 2 of the Schedule hereto and shown by a bold broken line on the said plan.
3. The said diversion of the bridleway shall have effect on the date Herefordshire Council certifies that the terms of Article 2 herein have been satisfied.
4. Where immediately before the date on which the said bridleway is diverted there is apparatus under, in, on, over, along or across it belonging to statutory undertakers for the purpose of their undertakings, the undertakers shall continue to have the same rights in respect of the apparatus as they then had.
5. The rights conferred on the public under this order shall be subject to the limitations and conditions set out in Part 3 of the Schedule hereto.

PART 1

Description of Site of Existing Path or Way

The existing route of bridleway CL70 commences at County Road U75201 at OS Grid Reference SO 2665, 4623 (point A on the order plan) then travelling in a generally easterly direction for approximately 116 metres along a track, then continuing in a generally east-south-easterly direction past the farm and through fields for approximately 499 metres to OS Grid Reference SO 2719, 4600 (point B on the order plan).

The total length of the existing said bridleway is approximately 615 metres.

PART 2

Description of Site of New Path or Way

The proposed new route of bridleway CL70 being 3 metres in width commences at County Road U75201 at OS Grid Reference SO 2656, 4594 (point C on the order plan) and travels in a generally east-north-easterly direction for approximately 20 metres and passes through a field gate to OS Grid Reference SO 2659, 4595 (point D on the order plan) then continues in a generally east-south-easterly direction for approximately 143 metres to OS Grid Reference 2671, 4589 where it passes through a field gate, then continuing for a further 38 metres to OS Grid Reference SO 2675, 4589 (point E on the order plan) where it turns and continues in a generally north-north-easterly direction for approximately 99 metres to OS Grid Reference SO 2680, 4598 (point F on the order plan) where it passes through a field gate and continues in a generally easterly direction for approximately 240 metres to OS Grid Reference SO 2704, 4602 (point G on the order plan) then continuing for approximately 155 metres to a field gate at OS Grid Reference SO 2719, 4600 (point B on the order plan).

The total length of the said proposed new bridleway is approximately 695 metres.

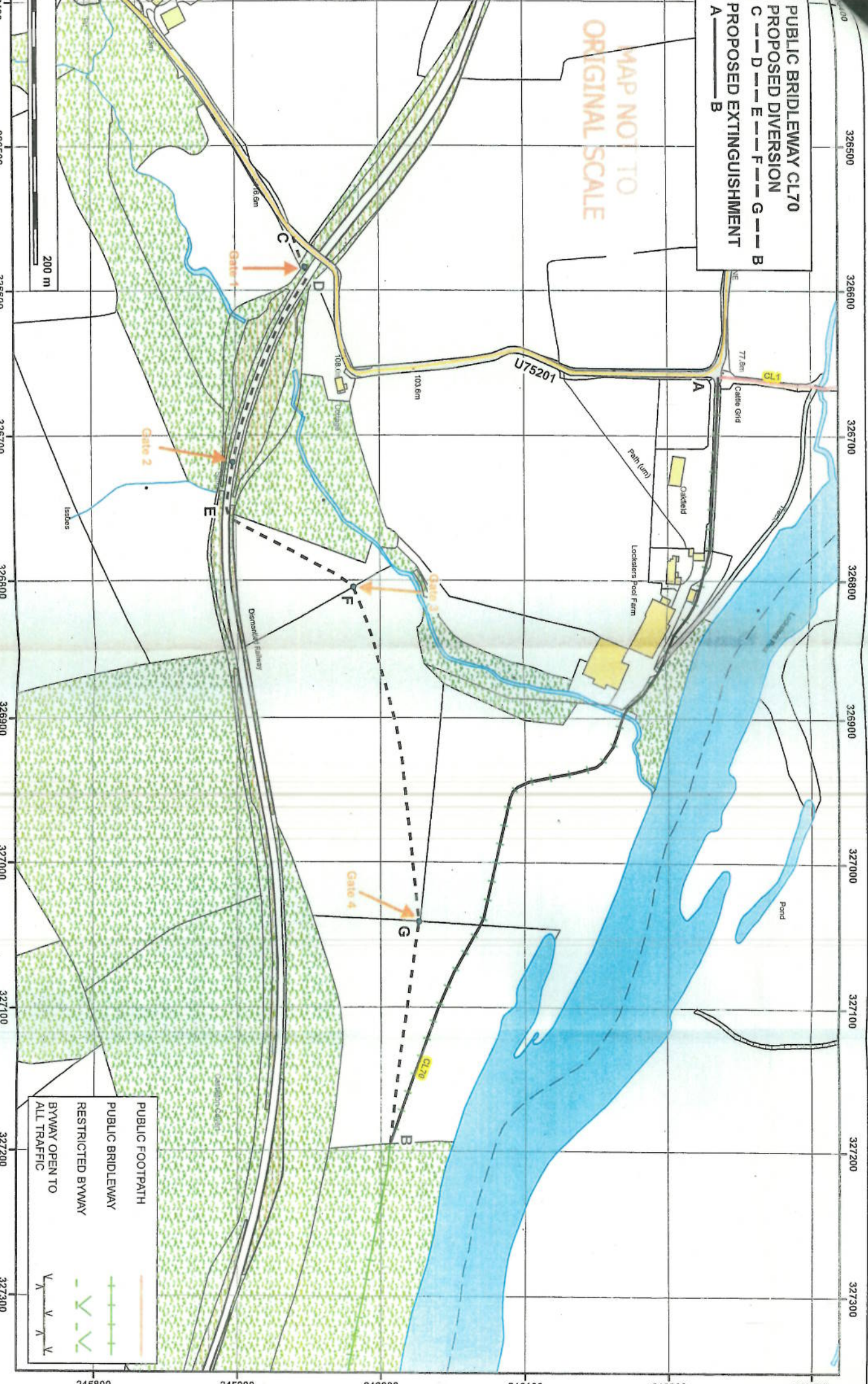
