Suffolk County Council (Parish of Cavendish) Modification Order 2016

Notice is hereby given that the above referenced Orders has been submitted to the Secretary of State for Environment, Food and Rural Affairs for determination. Following an earlier exchange of written representations, the Inspector appointed to determine the Order issued a letter in which he proposed to make modifications to the Order as drafted. Following advertisement of those proposals objections/representations have been received.

The **start date** for the above Order is 22 May 2017.

Consideration of the Order will take the form of exchanges of statements of case and comments on statements of case which contain evidence in respect of the modified part of the Order and new evidence in respect of the unmodified part of the Order.

The effect of the Order, if confirmed without modifications, will be to modify the definitive map and statement for the area by realigning part of FP5 in the meadow north of the river from Ordnance Survey Grid Reference (OSGR) 58090,24642 to its junction with Pentlow Lane (B1064) at OSGR 58107,24640. The amended alignment runs from OSGR 58090,24642 via a point on the north bank of the river at OSGR 58097,24638 to a junction with Pentlow Lane (B1064) at OSGR 58106,24641. The entire length of FP26 is to be deleted from its junction with the original alignment of FP5 at OSGR 5896,24640 to the north bank of the river at OSGR 58097,24637. All as shown on the order plan.

The effect of the proposed modifications would be

In the Schedule to the Order, Part I, add to the description of the path to be added after 'OSGR 58106,24641' the words "and branching from the same path where it meets the north bank of the river at OSGR 58097,24638 in a southerly direction across the River Stour to the County boundary".

In the Schedule to the Order, Part II, delete the words "*The particulars of footpath 5 are to be unchanged."* And add:

"Particulars of footpath to be modified

Add at the end of the Definitive Statement for Highway No.5 the words 'and branching from the same path where it meets the north bank of the river in a southerly direction across the River Stour to the County boundary'."

Amend the Order Map accordingly.

Copies (excluding copies of any supporting documents - these will be available to view at the Authority's offices) will also be sent to everyone who has made an objection or representation following the proposed modifications, the applicant and any other person who has previously written to us in respect of the Order.

Within 14 weeks of the start date [by 29 August 2017]

Everyone who has made an objection or representation following the proposed modifications, the Authority, the applicant (if applicable) and anyone who has written to us in respect of the Order must ensure their comments on any or every other statement of case is received by the Secretary of State. As soon as possible after the above date, the Secretary of State will send copies of the comments received to everyone else.

Any other person wishing to make representations in writing to the Secretary of State in respect of the above Order must do so in line with the timetable set out above.

All parties must keep to the timetable set out above and ensure that statements of case are received by the Secretary of State on time. Late documents will be returned.
