SUPPLY AND INSTALLATION OF NEW CENTRAL AIR CONDITIONING SYSTEM

1.0 BACKGROUND INFORMATION

The Foreign & Commonwealth Office (FCO) are seeking expressions of interest from experienced contractors for replacement of central air conditioning system and related works.

1.1 THE REQUIREMENT

The project is for the replacement of the central air conditioning system to the British High Commission, Lusaka, Zambia. The Client will be Her Britannic Majesty's Secretary of State for Foreign and Commonwealth Affairs, hereinafter referred to as FCO.

The procurement strategy will include an element of contractors design items, and the tendering strategy will be competitive tender to a maximum of five companies selected after this pre-qualification stage.

The aim of the project is to remove the existing mix of central air conditioning and split systems from the building. These are to be replaced with a central system serving all unclassified areas of the property.

The works comprise of the removal of the existing system and installation of the new system and all associated builders work in connection. The site is split over three floors of the same building with a combined floor area of approximately 500m2

The works include the supply, shipping and installation of a new central air conditioning system and associated plant following the completed design specification.

Further information, detailed specification and drawings will be included in the Invitation to Tender package.

This project will be contracted using the NEC form of contract.

Potential Providers are required to submit their completed PQQ via the Authority's eProcurement portal. There may be restrictions regarding the length of answers or attachments and anything in excess of this may be disregarded.

Express an Interest in the Tender - Login to the portal with the username/password - Click the "PQQs/ITTs Open to All Suppliers" link. (These are Pre-Qualification Questionnaires or Invitations to Tender open to any registered supplier) - Click on the relevant PQQ/ITT to access the content - Click the "Express Interest" button in the "Actions" box on the left hand side of the page - This will move the PQQ/ITT into your "My PQQs/My ITTs" page (This is a secure area reserved for your projects only) - You can now access any attachments by clicking the "Settings and Buyer Attachments" in the "Actions" box; 3. Responding to the tender - You can choose to "Reply" or "Reject" (please give a reason if rejecting) - You can now use the 'Messages' function to communicate with the buyer and seek clarification - Note the deadline for completion, then follow the onscreen instructions to complete the PQQ/ITT - There may be a mixture of online & offline actions for you to perform (there is detailed online help available), You must then publish your reply using the publish button in the "Actions" box on the left-hand side of the page. Potential Providers should answer all questions as accurately and concisely as possible in the same order as the questions are presented. Where a question is not relevant to the Potential Provider's organisation, this should be indicated, with an explanation. Where attachments are requested to be submitted within the electronic PQQ, these shall be submitted in a PDF format (Adobe or similar).

Bids not submitted via the FCO's eProcurement portal will not be considered.
