Consultation on the Reform of Fisheries Management Arrangements - England.

I am writing to seek your views on the Government's proposals to reform the fisheries management arrangements for the English fishing fleet.

Fisheries play an important role in providing food, jobs, wealth, and social/cultural benefits, particularly in some coastal communities. The English under-10m fleet (often referred to as the 'small scale' fleet or the 'under 10s') has failed to thrive under successive management regimes, and it faces major challenges. Specifically, the current regime has encouraged an imbalance between capacity and fishing opportunities, putting pressure on smaller businesses. These problems have been compounded by rising fuel/operating costs, increasing competition for fishing grounds with the development and expansion of renewable energy sites and marine protected areas, and continually reducing quotas.

This consultation sets out proposals for fisheries management reform in England designed to secure a more profitable, sustainable and unified fishing industry in the long term. The key elements include:

- the establishment of community quota models in England, in areas that wish to safeguard a small-scale/community fleet;
- the allocation of clearer, more stable and predictable entitlements to fish across the whole English fleet, using the existing Fixed Quota Allocation mechanism;
- safeguards to help retain fisheries access rights in small scale/community fleets and prevent the concentration of rights; and
- some re-alignment of fishing opportunities across the English fleet, including that associated with consistently un-fished allocations. We are considering how this measure might be used to incentivise English community quota models.
