Consultation on a proposed Legislative Reform Order to amend the Veterinary Surgeons Act 1966

I am writing to invite views on a proposal to make a Legislative Reform Order (LRO) to amend the Veterinary Surgeons Act 1966 that will enable the Royal College of Veterinary Surgeons (RCVS) to change the constitution of its Disciplinary Committee (DC) and Preliminary Investigation Committee (PIC).

The Royal College of Veterinary Surgeons (RCVS) governs the veterinary profession through its Council and system of committees. This includes the two statutory committees that deal with disciplinary proceedings – the Preliminary Investigation Committee (PIC) and Disciplinary Committee (DC). RCVS Council both sets the standards for the profession and, through these statutory committees, deals with any possible breaches of those standards, thus there is an overlap of functions. This system is now considered to be inflexible, insufficiently impartial and out of date when compared to the 'best practice' seen in other comparable professions. The proposed amendment to the Veterinary Surgeons Act 1966 will separate this overlap of functions thus reflecting better the role of RCVS in balancing public and professional interests. In addition, the current legislation restricts the size of the committees making it difficult for them to manage the caseload, a situation which is unsustainable for the future.
