MR SPEAKER, FOR THE CONVENIENCE OF THE HOUSE, I WISH TO ANNOUNCE THE PROPOSED CALENDAR FOR THE COMING YEAR.

WE INTEND FOR THE HOUSE TO RISE AT THE CLOSE OF PLAY ON TUESDAY 15 NOVEMBER, RETURNING MONDAY 21 NOVEMBER – MEANING WE WILL NOT SIT ON WEDNESDAY 16 NOVEMBER OR THURSDAY 17 NOVEMBER AS PREVIOUSLY PLANNED.

THE HOUSE WILL RISE FOR THE CHRISTMAS RECESS AT CLOSE OF PLAY ON TUESDAY 20 DECEMBER, RETURNING ON TUESDAY 10 JANUARY 2012.

THE HOUSE WILL RISE FOR THE CONSTITUENCY BREAK AT THE CLOSE OF PLAY ON THURSDAY 9 FEBRUARY, RETURNING ON MONDAY 20 FEBRUARY.

WE WILL RISE FOR THE EASTER BREAK AT CLOSE OF PLAY ON TUESDAY 27 MARCH, RETURNING MONDAY 16 APRIL

WE WILL RISE FOR THE WHITSUN RECESS AT CLOSE OF PLAY ON THURSDAY 24 MAY, RETURNING MONDAY 11 JUNE
