ABPs excluded from the ABPI (Regulations 3(2) and 5):

Regulations:

3(2) any animal excreta or catering waste or meat cooked at a knacker's yard to feed animals not for human consumption.

5(1) (a) the green offal of wild game killed in the wild which is removed from the carcase and left at the point of killing or vicinity;

5(1) (b) any ABP (to be) removed from premises for inspection by a veterinary surgeon (or on his behalf);

5(1) (c) waste product left after feeding ABP to zoo, circus or fur animals, hounds or maggots farmed for fishing bait, which no longer looks like meat;

5(1) (d) any ABP imported into GB for use for scientific purposes;

5(1) (e) any ABP which is, or is derived from, a **product of animal origin** regulated by Regulation 1069/2009 and transhipped as per regulation 24 of the Products of Animal Origin (Import and Export) Regulations 1996

5(1)(f) SRM;

5(2)(a) poultry heads and feet subjected to a post-mortem veterinary inspection which did not show gross pathological lesions indicating disease communicable to man or animals;
