### More support for women in business

On 4 November the Minister for Women announced that the Government would be looking at what more could be done to ensure that women were fully able to use their talents to support both themselves and economic growth. To ensure Government get the best advice we will be setting up a Women's Business Council. The details are still being worked out but we expect the group to look at a range of issues including;

- Supporting more women to become entrepreneurs
- Tackling obstacles to making best use of women's skills (which could include childcare, careers advice, skills, rolling out Voluntary Gender Equality Reporting)
- Road testing existing policies and programmes to ensure relevance for women in business.

As more immediate support for women in business the Government will be funding the recruitment and training of 5,000 new mentors to support women set up and grow their businesses.

### **Civil Partnerships on Religious Premises**

The Government ran a consultation between March and June this year on the practical arrangements necessary to implement section 202 of the Equality Act 2010. Making this change will allow those religious organisations that wish to do so to host civil partnership registrations on their religious premises. This voluntary provision is a positive step forward for both LGB rights and religious freedom.

The Government response to this consultation was published on 2 November along with a copy of the draft regulations. We are grateful to everyone who submitted a response. Over 1600 responses were received and all were individually considered in formulating the final regulations. The regulations have now been laid in both Houses. The *Charter for Action* was launched by Equalities Minister Lynne Featherstone in March, in partnership with major national sports governing bodies this year. It calls for anyone with an interest or involvement in sport to unite in a common cause to challenge discrimination both on and off the pitch.

These football teams join a growing list of supporters for the campaign including rugby union's Ben Cohen and tennis stars Martina Navratilova and Billie Jean King, the Football Association, the Lawn Tennis Association, the England and Wales Cricket Board, the Rugby Football League and the Rugby Football Union.

To build on this work, we have developed a new <u>toolkit</u> to help National Governing Bodies and sports clubs raise awareness of the issue and promote the action they are taking to tackle homophobia and transphobia in sport.
