Could you please provide details of the subject (s) under discussion?*

*2...During the aforementioned period has the department awarded a contract to Dechert or commissioned the company to carry out any sort of work on its behalf. Could you please provide details of any contract (s) including value, duration, purpose and the date it was agreed. Can you please explain what work the firm has carried out on behalf of the department.*

*3....Could you please provide copies of all correspondence and communications (including emails) exchanged between the aforementioned company and the department.*

*4....During the aforementioned period has any member of the ministerial team met with an employee and or representative of the Spanish construction company Acciona. If the answer to the above question is yes can you please identify the Minister (s) and provide*

*the date, time and venue of the meeting (s). In the case of each meeting can you please provide a list of other individuals present including departmental employees and or representatives as well as employees and or representatives of Acciona. Could you please provide details of the subjects under discussion.*

*5...During the aforementioned period has the department awarded a contract to Acciona or commissioned the company to carry out any sort of work on its behalf? Could you please provide details of the contract (s) including value, duration, purpose and the date it was agreed. Can you please explain what other work the company may have carried out on behalf of the department.*

*6...Could you please provide copies of all correspondence and communications (including the emails) exchanged between the aforementioned company and the department.*

*7...Has Miriam Gonzalez Durantez, the wife of the Deputy Prime Minister, met with any member of the ministerial team or any member of the department's staff to discuss either of the aforementioned companies or issues of relevance to them. If so can you please provide details of any meeting including a full list of those present as well as the date and venue. Can you please describe the subjects under discussion.*
