#### 1. Introduction

#### Aim

- 1.1 This consultation focuses on:
  - 1) proposals to reduce non-financial annual data returns from Fire and Rescue Services to the Department for Communities and Local Government's (the Department).
  - 2) proposals to terminate of the majority of data collected on 'Fires of Special Interest forms.
- 1.2 The consultation will run from **Friday 26 November 2010 to Friday 14 January 2011**.

#### Background

#### Non-financial annual returns from Fire and rescue Services

- 1.3 Fire and Rescue Services have long provided annual returns on a range of subjects including: fire safety audits, health and safety, community fire safety activity, other operational statistics such as on numbers of emergency calls, and staffing numbers. Twenty-one tables have been discontinued over the last two years largely following the 2009 Review<sup>1</sup>. However, there have been far greater increases in volumes of equality and diversity data tables over recent years.
- 1.4 Headline statistics are published in Fire and Rescue Operational Statistics<sup>2</sup>, along with more detailed data tables.
- 1.5 Users of these statistics in recent years include:
  - Fire and Rescue Authorities
  - representative bodies
  - academics and other researchers
  - commercial organisations
  - government departments
  - Office for National Statistics
  - members of the public.

#### Fires of Special Interest (FOSI) forms

- 2.3 In order to remove duplication and ease administrative burden, we propose that the requirement to complete and return Fires of Special Interest forms as set out in *Fire and Rescue Service Circular 22-2006* will end.
- 2.4 This would apply to all types of Fires of Special Interest forms including acetylene cylinder incident forms, but with the exception of "Category A6" returns. These are where a fire has occurred in a Crown premise and would still be required.
- 2.5 Additionally, the Department would like to continue to receive notification by phone or email to the Chief Fire and Rescue Advisor duty officer of:
  - serious injury or death of a firefighter
  - significant incidents and/or multiple fatalities.
- 2.6 It would not necessarily follow that individual Fire and Rescue Services should stop collecting other types of Fires of Special Interest form information for their own purposes, if it is felt locally that there is a use or need, or where there is a requirement to do so, such as Health and Safety recording.
- 2.7 Equally, this only applies to the completion and return to the Department of the actual Fires of Special Interest forms; it does not mean that information collected elsewhere on similar subjects such as in the Incident Recording System will stop.

#### 3. Responses to this consultation

#### Consultation questions

3.1 If possible, we would particularly appreciate responses to be structured to address the following questions.

#### 1. Annual returns (see 2.2)

- a) Are there any data items for which it is proposed to no longer collect, that you consider should be retained as national data sets?
- b) Of the data items for which it is proposed to continue to collect and compile into a national data set, which would you use?
- c) Do you have any suggestions for alternative or additional data collection not included in this consultation?
  - In answers to both a), b)and c), it is vital that you explain what data have or would be used and how, and in particular, the decisions informed by the relevant data.
- d) Do you have any further comments in relation to using the data from these Annual Returns? For example on the data themselves, or on the publication *Fire and Rescue Operational Statistics* and its accompanying data tables<sup>3</sup>.
- e) Overall, how do you consider the balance between value and burden of:
  - i) the proposed new arrangement of 23 tables.

#### 6. About this consultation

- 6.1 This consultation document and consultation process have been planned to adhere to the Code of Practice on Consultation issued by the Department for Business Innovation and Skills and is in line with the seven consultation criteria, which are:
  - 1. Formal consultation should take place at a stage when there is scope to influence the policy outcome.

# Appendix A Fires of Special Interest

Arrangements have been in place for some years for the Department for Communities and Local Government (the Department) to be notified of key fire safety matters. These are termed "Fires of Special Interest". Details of FOSIs are passed to DCLG in accordance with Fire and Rescue Service Circular 22-2006.

The arrangements outlined in Circular 22-2006 include the use of four electronic templates for reporting Fires of Special Interest (FOSI)under the following headings:

- 1) "FOSI A" Standard FOSI notification
- A1 Fire fatality
- A2 Significant impact on the general public
- A3 Abnormally fast fire spread
- A4 Exceptional (over or under) performance of fire safety/CFS measures
- A5 Significant operational difficulties
- A6 Fire on Crown premises
- 2) "FOSI B" Death of a firefighter on duty
- B Death of a firefighter
- 3) "FOSI C" Attacks on fire fighters and civil disturbances
- C Attacks on firefighters and civil disturbances
- 4) A monthly return of the numbers of FOSI Cs

There is also a form for incidents involving acetylene cylinders although not formally part of the FOSI collection, is widely considered to be part of this data collection.

A FOSI form is an electronic word document that is completed by an individual within an FRS when incidents outlined above occur. They contain very basic information about an incident. They are emailed to the Department for collation.

It was intended that the data would be used by the Department to identify and monitor trends and to provide advice to Fire and Rescue Services. The data was also to be used as background information for ministers and other senior officials.

None of the information collated by the Department is published but it is made available upon request.

There are significant issues with this data collection that challenge its validity and reliability leading to both under-reporting and over-reporting of events depending upon the type of incident. The manual completion and return of forms to the Department by Fire and Rescue Service staff is also time consuming and burdensome.

Much of the data collated via Fire of Special Interest returns now can be retrieved from other, more reliable sources. For instance attacks on firefighters are now recorded in the new Fire and Rescue Incident Recording System which went live nationally on 1 April 2009. The first full year of data (up to March 2010) has been available since the end of August 2010.
