Charitable Giving Indicators 2010/11

Background

This release reports both the DCMS impact indicator "Total amount of charitable giving ¹ to cultural institutions we fund" and the input indicator of "ratio of charitable giving to Grant-in-Aid". The cultural institutions contributing towards this measure are, Arts Council England and their Regularly Funded Organisations, British Film Institute, British Library, English Heritage, and the National Museums and Galleries.

Findings

1) Impact Indicator




Figure 1: Total income breakdown for DCMS-funded cultural institutions, 2010/11

In 2010/11, the cultural institutions we fund collectively raised around £250.4m in contributed income (as defined in the technical annex below). £16.8m of this was from donated objects (6.7% of all contributed income). A breakdown of this against the total income of cultural institutions is show in the pie chart below. The total income of these bodies in 2010/11 was £2.557bn (see Figure 1).

2) Input Indicator

The ratio of charitable giving to Grant-in-Aid (input indicator) is **23.9%.** This means for every £1 of Grant-in-Aid received by cultural institutions DCMS fund, these institutions generated around 24 pence in fundraising/contributed income. Excluding donated objects, the percentage of charitable

giving to Grant-in-Aid was 22.2% (i.e. 22 pence) in 2010/11.

Change since 2008/09

In 2008/09 the total amount of charitable giving received by the same cultural institutions reached £304m². However a third of this (£100.3m) was from donated objects, including £31.9m worth of donated objects given to the National Gallery, and £64m worth of objects donated to the Tate.




Figure 2: Total charitable giving for DCMS-funded cultural institutions 2008/09 - 2010/11

Therefore, excluding donated objects, charitable giving to cultural institutions funded by DCMS increased from £203.6m in 2008/09 and £217.5m in 2009/10 to £233.6m in 2010/11 (an increase of 7.4% since 2009/10). This is illustrated in figure 2 below.

Since 2008/09, cultural institutions DCMS fund have collectively raised nearly £790m in fundraising/contributed income.

Further Detail

A published table³ with individual breakdowns by cultural institutions accompanies this report. Individual breakdowns have been included for transparency purposes, to show how the totals were calculated, and are *not* reported for comparisons between cultural institutions.

Annex A: Technical Note

Definition

Fundraising/contributed income is defined as any money or gift received from an individual, charity or private company, which is from one of the following: bequests, legacies, donations and capital grants from individuals, charities, foundations, trusts and private companies, as well as income raised through sponsorship and income from membership schemes.

This should not include any money received from a publicly funded organisation, central government grants, investment income or lottery grant funding.

We have summarised this in the table below:

^{*}All "not included" would be categorised as other income in Figure 1.

The DCMS Grant-in-Aid figure is taken from the DCMS internal accounting system which reports the actual Grant-in-Aid sponsored bodies received. This excludes other public funding such as Strategic Commissioning, the Wolfson Foundation fund, and grants to the National Historic Ships Committee.

Sources

The sources used to calculate these indicators are derived from individual sponsored organisation's statutory accounts.

The source used for the Arts Council England's Regularly Funded Organisations is the RFO annual submission. The figures reported are from the full sample in $2008/09^4$ (850 RFOs), $2009/10^5$ (836 RFOs) and $2010/11^6$ (829 RFOs) for "Contributed income, which includes sponsorship, trusts and donations".
