CONSULTATION ON REFORMING THE GB ANIMAL WELFARE INSPECTION REGIME

I am writing to invite views on the proposals in the attached consultation document to reform the animal welfare inspection regime in Great Britain to reduce the likelihood of inspection to farms at low-risk of non-compliance with animal welfare legislation.

Animal welfare on farms is currently monitored and enforced officially by Government delivery bodies (the Animal Health & Veterinary Laboratories Agency (AHVLA) and local authorities), predominantly on a risk basis. Many of the proposals put forward to achieve this reform involve changes to the risk inspection model used by AHVLA for inspections to claimants under cross compliance regulations. AHVLA operates on a GB basis. Hence this is a joint consultation involving Defra, the Welsh Government (WG) and the Scottish Government (SG).

Main proposal

The main proposal set out in the consultation document is that membership of a farm assurance scheme or certification under an organic scheme, should be included as a criteria in AHVLA's risk model for allocating inspections to claimants under cross compliance regulations for 2012 and beyond. This proposal is supported by research, commissioned by Defra and WG and carried out by the University of Warwick in 2010, which showed that farms which are members of farm assurance schemes or certification under an organic scheme, should be considered for inclusion in the risk model as a reduced risk.

Such an approach applies the principle of "earned recognition" as put forward in the recently published report by the independent Farming Regulation Task Force¹. Earned recognition requires regulators to use private sector information and other personal evidence to assess risk and therefore the need for the state or its agents to inspect. Recognition is "earned" because it rewards the effective efforts of individuals or businesses to improve knowledge, competence or standards.

Other proposals

The consultation document describes other potential criteria for AHVLA's risk model. It is proposed that these are considered for possible future inclusion in the risk model (2013 and beyond) where robust supportive evidence is found.

There is scope to achieve further efficiencies in animal welfare inspections through, for example, the use of risk-based decision tools, the sharing of information and by taking a more joined-up approach to inspections both at Government level and wider. All of these initiatives will help to reduce burdens on farmers, and will make better use of Government resources. The consultation document gives examples of where this has already started to happen and considers avenues for future exploration.

Impact Assessment

An impact assessment has not been prepared. This is because proposed changes to the AHVLA risk model for allocating inspections will not result in a change in the overall level of regulatory activity. Although there will be costs to the public sector in terms of changes to the IT specification, these will be well below the threshold of £5 million. There are potential savings around efficiencies in inspections but ideas are not sufficiently developed to allow any meaningful assessment to be carried out at this stage. The benefits and drawbacks of each proposal are set out in the consultation document.
