At Annex B, you can find the number of theory tests conducted with a voiceover or translator in Scotland in each of the financial years from 2008/9 to 2010/11. We have also provided you with the language in which the voiceover was provided or the test was translated in to.

Please note that:

- we provide the voiceover in 21 languages for the car and bike theory test only. We provide only the English and Welsh voiceover for the other categories of test.
- a candidate doesn't need to have a voiceover on test; candidates sitting their test in English or Welsh can do so by reading the text on screen. Some candidates, however, opt to have the English or Welsh voiceover as well as the onscreen instructions/test.
- a candidate can have a translator at the theory test
