Yarmouth (Isle of Wight) (Revocation) Byelaws 2012

The Secretary of State has considered the application for confirmation of the above named byelaws made under article 18 of the Yarmouth (Isle of Wight) Harbour Revision Order 1971.

The Yarmouth (Isle of Wight) Authority's case for the Byelaws

The Yarmouth (Isle of Wight) Harbour Authority requires its 1973 byelaws to be revoked, because they have been superseded by the 2012 Yarmouth (Isle of Wight) General Directions.

Sealing and advertisement of the Byelaws

The byelaws were sealed by The Common Seal of the Yarmouth (Isle of Wight) Harbour Commissioners on 28 May 2012. A public notice was placed in the Isle of Wight County Press on 15 June in accordance with section 86 of the Harbours, Docks and Piers Clauses Act 1847.

No objections or representations were received during the advertising period.

The Decision of the Secretary of State

In general, the reasonableness of byelaws is in the first place one to be considered by the authority making them. The Secretary of State agrees that the 1973 byelaws are superseded by the 2012 Yarmouth (Isle of Wight) General Directions and that consequently the Yarmouth (Isle of Wight) Harbour Authority has reasonable grounds for revoking them by making the Yarmouth (Isle of Wight) (Revocation) Byelaws 2012.

The Secretary of State has therefore decided that the byelaws be confirmed.

The byelaws shall come into force on the expiration of 28 days from the date of that confirmation.
