

## **BLOODY SUNDAY INQUIRY: EXPENDITURE BY YEAR AND BY CATEGORY**

Total cost of the Bloody Sunday Inquiry to the end of May 2010 is **£191.2 million**

This includes:

**£155.6 million** incurred by the Inquiry (funded by the Northern Ireland Office) and;

**£35.6 million** incurred by the Ministry of Defence.

Ministry of Defence costs are split into:

**£32.6 million** for legal fees and;

**£3.03 million** for other costs, which include inquiry-related staff and support costs, a police investigation and other miscellaneous fees and expenses.
