

**1) The total number of car practical tests terminated in the interests of public safety and those vehicles that were fitted with dual controls and those that weren't in each of the calendar years from 2007, 2008, 2009, 2010, 2011 for each of the following test centres:**

- a) Barnsley**
- b) Doncaster**
- c) Rotherham**
- d) Sheffield (Middlewood Road)**
- e) Sheffield (Parkway)**

At Annex B, you can find the number of car practical tests terminated in the interests of public safety that were fitted with dual controls and those that weren't for each calendar year from 2007 to 2011. We've provided this information for each of the five test centres you have requested the information for.

Please note that the existing Sheffield (Parkway) test centre opened on 9 April 2009. Therefore the information provided in responses one to five on this test centre is from that date until 31 December 2011 by calendar year.
