3) Nationally the age and sex of the candidates who have taken each test (car theory test and car practical test) the greatest number of times and the number of times they have taken it in 2010/11

In 2010/11 the greatest number of attempts at the car theory test was 28. This candidate was female and aged 28.

4) Nationally the gender of the candidate who has taken the car practical test the greatest number of times and the number of times they have taken it in 2010/11

In 2010/11 the greatest number of attempts at the car practical test was 16. Two candidates attempted their car practical test on 16 occasions; one candidate was female and the other was male.

5) The age and sex of the candidate that has taken the car theory test the greatest number of times and the number they have taken at Canterbury theory test centre in 2010/11

In 2010/11 the greatest number of attempts taken at the car theory test at Canterbury theory test centre was 11.

Any information that can be linked to an individual is classed as personal data and, as such, is exempt from release under section 40 (2) of FoIA. We have, therefore, withheld the age and gender of the candidate to prevent this becoming personal data. This exemption in full is attached at Annex C.

6) The age and sex of the candidate that has taken the car practical test the greatest number of times and the number they have taken at Canterbury DTC and Herne Bay MPTC in 2010/11

In 2010/11 the greatest number of attempts taken at the car practical test at Canterbury DTC was eight. Three candidates attempted their car practical test at Canterbury DTC on eight occasions in 2010/11.

In 2010/11 the greatest number of attempts taken at the car practical test at Herne Bay MPTC was 12.

Any information that can be linked to an individual is classed as personal data and, as such, is exempt from release under section 40 (2) of FoIA. We have, therefore, withheld the age and gender of the candidates that took the greatest number of attempts at the car practical test at Canterbury DTC and Herne Bay MPTC in 2010/11 to prevent it becoming personal data. This exemption in full is attached at Annex C.
