#### Answer -

No information is held for the category of Medical because the Data protection act prohibits that we disclose this information for statistical purposes. For fitness, the information is not broken down to that level of detail as the reason for failing a fitness test is not specified but rather a pass or fail is recorded. For Age, Nationality and Academic, to provide this data would mean manually trawling through thousands of records. For example, for academic alone, to show all qualifications (types / subjects / grades and Basic Skills etc) declared for each candidate would exceed the cost set limit. This limit is specified in FOI regulations and for central government is set at £600. This represents the estimated cost of one person spending 3 and a half working days in determining whether the Department holds the information, and locating, retrieving and extracting the information. Under the terms of Section 12 of the FOI Act, this means that we are not obliged to comply with your request.

I am sorry that I am not in a position to fully answer your questions but hope that you find the information above to be helpful.

If you are not satisfied with this response or you wish to complain about any aspect of the handling of your request, then you should contact me in the first instance.
