Railway transport services. This notice involves a Part B public services contract (see Section VI.3 below for additional information on the procurement process that will be operated). The DfT is seeking to appoint an appropriately experienced and qualified transport operator to operate the Greater Anglia rail passenger franchise. Expressions of interest are now being sought from the market and shortlisted applicants will receive the Invitation to Tender planned to be issued in April 2011. It is expected that the winning bidder will be announced in autumn 2011 with the contract commencing in February 2012. The length of the franchise will be a minimum of 1 year and 6 railway periods, with pricing also provided for a potential extension of up to 1 year. The future franchisee should have sufficient financial backing to place a performance bond and a season ticket bond. These are expected to be up to GBP 10 million and GBP 50 million respectively.

- II.2) Quantity or Scope of the Contract

The Greater Anglia franchise provides local, suburban and express train services from London Liverpool Street to north and east Greater London, Essex, Hertfordshire, Cambridgeshire, Suffolk and Norfolk. Greater Anglia combined train services previously operated by Anglia Railways, First Great Eastern and the West Anglia part of the WAGN operation including the Stansted Express in April 2004. In 2009/10 the services that make up the current Greater Anglia franchise had total passenger-related revenue of 510 million GBP, 107 million passenger journeys and 2.3 billion passenger miles. The Department will take revenue risk and the franchisee will take cost risk for the period of the Greater Anglia contract. The contract will be based on the revised National Rail Franchise Terms with bespoke provisions for the revenue and cost arrangements that will apply. No major service changes are planned for the duration of the contract. The franchisee will be required to operate the timetable that is in place at the start of the contract and implement the December 2012 timetable change. The franchisee may be required to take full repairing leases for some or all of the stations that it operates. Further details will be set out in the Invitation to Tender issued to shortlisted applicants.

The franchising procurement process is being undertaken in pursuance of the Railways Act 1993 (as amended). It is a Part B Services Contract and is therefore voluntarily utilising an OJEU Notice.
