Thank you for your correspondence dated 16 April which has been considered to be a request for information in accordance with the Freedom of Information Act 2000. It has been passed to my department and I have been asked to respond.

You have asked the following questions:

- 1. For the last calendar year 2011 please state how many positive drugs tests were recorded following tests carried out on members of the armed forces?
- 2. If possible please provide a breakdown of those positive tests by type or class of drug?
- 3. For the 2011 figure of positive drug tests please provide a breakdown by army corps (as per the definition provided in Parliamentary Written Answer 190801).

Misuse of drugs in the Armed Forces is inconsistent with Service life and our policy can be described as 'zero tolerance'. Although any Serviceman/woman found to have been taking drugs can expect to be discharged, 'zero tolerance' does not bind the Forces to discharge as its only response to drug misuse. If there are exceptional circumstances and the chain of command can provide a justification for the unusual response of retention, then it will be considered.

Please find in the table below the information requested for questions one and two.

Please be advised that this is the number of tests carried out not the number of personnel tested. Also it is not uncommon for an individual to return positive urine analysis for more than one drug, hence the disparity in data. Likewise some individuals return positive analysis on numerous tests.

For your third question, below is a table of Army regiments with the number of positive tests against each unit. Again please be advised this does not relate to the number of personnel only the number of positive results. The size of each Corps and Regiment will vary and will be dependent on the number of specialisations contained within it.
