The purpose of this Information Note (IN) is to remind those responsible for or involved with Technical Inspections (TI) and Professional Appraisals (PA) of Explosives Storage & Processing Facilities to ESTC Standard 6, Part 2 (B&CE), dated March 2011, of the requirement to send copies of the final signed off inspection reports to ESTC Technical Advisor (Structures). Clause 8.10.1 of ESTC Standard 6, Part 2 (B&CE) dated March 2011; issued under cover of DIO Policy Instruction (PI) 11/11 refers.

Background

- This IN compliments the information given in PI 11/11 in connection with the Technical Assessment (TA) & Professional Appraisal (PA) of Explosives Storage & Processing Facilities and is to be read by all persons involved with any works and/or maintenance associated with the sites or facilities that are the subject of PI 11/11 or this IN.
- 2. The DIO Site Estates Team Leader (SETL) or appropriate MOD Officer is to arrange for the Maintenance Management Organisation (MMO) to carry out all actions required by this IN.
- 3. No work involving expenditure on a MOD account is to be carried out without the prior authority of the PM, SETL or the appropriate MOD Officer for the location or facility in question.
- 4. For MOD Establishments occupied by the United States Visiting Forces (USVF), the responsibilities of the Project Manager, SETL and MMO are mutually held by the USVF and DIO(USF). At an operational level, the jointly managed organisation is to ensure that the appropriate action is taken to implement the requirements of this Note. Where this IN requires procedures which differ significantly from normal USVF/DIO(USF) practice a relevant DIO(USF) Code of Practice is to be issued by DIO(USF).

Action Required

5. The purpose of this IN is to remind those responsible for or involved with the carrying out of Technical Inspections (TI) and Professional Appraisals (PA) of Explosives Storage & Processing Facilities to ESTC Standard 6, Part 2 (B&CE), dated March 2011 of the requirement to send copies of the final signed off inspection reports to ESTC Technical Advisor (Structures). Clause 8.10.1 of ESTC Standard 6, Part 2 (B&CE) dated March 2011, issued under cover of PI 11/11 refers.

6. The purpose of this IN is also to announce that an email Group Mailbox has now been set up to which the completed reports can be sent. The Group Mailbox address is as follows:

- 7. Please note that the above email address is not monitored and should only be used for the issue of completed ESTC Standard 6, Part 2 (B&CE) reports. For all other matters, ESTC Technical Advisor (Structures) should be approached using the address given in the 'Contact if different from above Sponsor' section at the head of this IN.
- 8. It has come to the attention of ESTC Technical Advisor (Structures) that the security systems of some Contractors computer systems interprets the Microsoft Excel spreadsheets in ESTC Standard 6, Part 2 (B&CE) as 'encrypted' and as such will not allow them to be sent via email. The reason for this is not clear as the spreadsheets are <u>not</u> encrypted (although they do contain macros). A solution to this is still being worked on, but in the meantime electronic copies of the reports may be burnt to compact discs (CDs) and sent to ESTC Technical Advisor (Structures) at the address given in Section 11.3 of ESTC Standard 6, Part 2 (B&CE), dated March 2011. Purpose

- 10. The purposes of submitting completed inspection reports to ESTC Technical Advisor (Structures) are as follows:
 - To enable the MOD Chief Inspector of Explosives and the MOD Explosives Storage & Transport Committee (ESTC) to monitor the condition of the explosives storage & processing estate over time.

- To ascertain if there are any common building defects or problems which are prevalent across the whole of the explosives estate to enable the appropriate corrective action to be taken centrally.
- To obtain feedback from the issued inspection/appraisal reports with a view to improving the content & usability of ESTC Standard 6, Part 2 (B&CE).
