#### Dear

Thank you for your correspondence dated 19 March which has been considered to be a request for information in accordance with the Freedom of Information Act 2000. It has been passed to my department and I have been asked to respond.

You asked the following question:

"How many men and how many women have, as serving members of the Royal Navy, Army and Royal Air Force, sought to be conscientious objectors in each of the following years: 1970 - 2011? Can you break down the yearly figures by gender? Can you indicate which were successful and which went to ACCO? Please supply me with separate figures for each service and each year."

The Ministry of Defence has a well-established procedure for Service personnel who, during their service, develop a genuine conscientious objection to further military service. Such cases are handled administratively by the Service concerned and are dealt with initially by the individual's chain of command. If the conscientious objection is considered genuine, arrangements are made for the applicant to be discharged from the Services on compassionate grounds.

The number of applications received for discharge from the Royal Navy, the Army and the Royal Air Force on grounds of moral, religious or political objection is set out below; unfortunately I have been unable to break these figures down by gender. Currently there is no information for 2011.
