

FREEDOM OF INFORMATION

Thank you for your Letter to the Scotland Office of 21 September 2012.

You asked for the following information under the Freedom of Information Act 2000:

A) Separately for 2010/11 and 2011/12 financial years, please state:

The total number of flights (separated into domestic and international) taken by Ministers within your Department.

- The total number of flights (separated into domestic and international) taken by Civil Servants/Officials within your Department.
- Where the information is held, please also state which UK airports the departures were made from. If the flights were domestic, please state both arrival and departure airports.
- B) Separately for the 2010/11 and 2011/12 please state:
 - The total number of occasions (specifying destination, purpose and nationality of the air carrier) on which your Department chartered an aircraft for the purpose of transporting people and/or cargo.
 - The total spend on travel using British registered air carriers
 - The total spend on travel using foreign registered air carriers

I am writing to confirm that the Scotland Office has now completed its search for information.

The flight information is highlighted in the table below:-



In 2010-11 Ministers took 25 return domestic flights and 0 international flights. Officials took 227 return domestic flights and 0 international flights. The departure and arrival airports were as follows:
