Please supply details of module one and module two bike tests conducted, passed and failed for categories P, A, A1 and A2 by age of candidate for the 2011 calendar year?

At Annex B, you can find information on the number of module one and module two bike tests conducted, passed and failed for categories A, A1 and A2 in 2011. To provide this information broken down by each age could lead to the identification of an individual. This information would be classed as personal data. Personal data is exempt from release under section 40 (2) of the Freedom of Information Act, a copy of which is attached at Annex C. We have, however, provided this information broken down by age bandings.

Please note that at Annex B there are some candidates where the age is 'unidentified'. These candidates took their bike practical test with a non-GB licence. We do not hold information on the age of these candidates.

We do hold information on the number of module one and two category P (or moped) tests conducted, passed and failed in 2011 broken down by age. However, due to the low number of tests conducted to provide this information broken down by age or age bandings could lead to the identification of an individual. This information is therefore also exempt from release under section 40 (2) of the FoIA. I can, however, provide you with the number of module one and two tests conducted, passed and failed in 2011; please find this information below.

- Category A1 – any motorcycle over 75cc and less than 125cc and capable of less than 62.5mph (100 km/h)
- Category A2 – any motorcycle over 120cc and less than 125cc and capable of at least 62.5mph (100km/h)
- Category A – direct access scheme and accelerated access – any machine of at least 35 kW (46.6 BHP). This category describes all bikes that are above 125cc.
- Category P – moped – maximum design speed not exceeding 50 km/h (about 31 miles per hour) and an engine capacity no greater than 50cc.
