1) How many companies are approved to deliver Driver Certificate of Professional Competence (CPC) training? I would like this number to include all consortium numbers (RTITB, System Training, Association of Trainers, etc).

On 31 October 2010, there were 947 centres approved to deliver Driver CPC training. This figure includes 13 consortium leads. This information is based on that captured on our recording and evidence system.

Please note that Driver CPC was introduced on 10 September 2008 for buses and coaches and 10 September 2009 for lorries.

2) From 2008 to October 2010 how many periodic Driver CPC training hours have been completed?

You can find the number of periodic training hours completed from 10 September 2008 to 31 October 2010 on our website at http://www.dft.gov.uk/dsa/category.asp?cat=776 This information is therefore exempt under section 21 (information accessible by other means) of the Freedom of Information Act. The information provided for LGV Driver CPC module four tests is for 10 September 2008 to 31 October 2010 and that for PCV Driver CPC module four is from 10 September 2009 to 31 October 2010.
