CONSULTATION ON ELECTRONIC REPORTING OF PIG MOVEMENTS IN ENGLAND

(Pigs, (Records, Identification and Movement) Order 2011)

I am writing to invite views on Defra's proposals to replace the current paper method of reporting pig movements in England with a pre-notification electronic system. The proposed system will be delivered in partnership with industry and will include a bureau service for those keepers who do not have access to computers. The existing Pigs (Records, Identification and Movement) Order 2007 (PRIMO) will be replaced by a new 2011 Order to accommodate the necessary legislative base.

We also invite comments on a few other changes to PRIMO. These are to permit the use of compressed air applied slap marks (tattoos) as an alternative to the use of standard manual application equipment, to reduce the retention period for on farm records from 6 years to 3 years and to require individual identification and recording for boars moving to artificial insemination centres.

The proposals build on an industry / Government pilot project on electronic reporting and have the support of the main bodies representing pig producers. This non-formal written consultation will last for four weeks.
