## FREEDOM OF INFORMATION

Thank you for your email which was received in the Scotland Office on 30 August 2012.

You asked for the following information under the Freedom of Information Act 2000:

*A list of all meetings attended by the Secretary of State for Scotland between 1st December 2011 and 11th August 2012*

I am writing to confirm that the Scotland Office has now completed its search for the information that you requested. I wish to advise you that some of the information requested has not been disclosed as it falls under exemptions contained in Sections 21 and 22 of the Freedom of Information Act 2000.

Under Section 21 of the Act, we are not required to provide information if it is already reasonably accessible to you. The Scotland Office has published details of Ministerial meetings with external organisations up to 31 March 2012. This information is available on the Department's website at <http://www.scotlandoffice.gov.uk/scotlandoffice/14542.html>.

Under Section 22 of the Act, we are not required to provide information if it is intended for future publication. The Scotland Office will publish details of Ministerial meetings with external organisations from 31 March to 11 August 2012 on the Department's website in due course. Upon publishing of this information, you can request details of Cabinet meetings and meetings with representatives of foreign governments by lodging a Freedom of Information request with us.

Furthermore, in the annex attached, I have listed the Cabinet meetings and meetings with representatives of foreign governments which the Secretary of State has attended during the period 1 December 2011 to 31 March 2012.

I hope that this information will be helpful to you.
