A regular communication on revalidation from the GMC

This week we launched a new campaign to work with responsible officers to agree the dates that licensed doctors will revalidate in the first, second and third years of revalidation - up to the end of March 2016.

This is an important campaign in our preparations for the introduction of revalidation later this year. We will use the schedules that are developed by responsible officers to agree the precise dates by which they will make their recommendations about individual doctors. Ideally, we want to be in a position to confirm these dates to all doctors from December onwards.

We have started to contact responsible officers about this campaign by email, and every responsible officer should have heard from us by Friday 6 July. The exceptions to this are responsible officers for postgraduate deaneries and the locum agencies that are part of the Government Procurement Service Framework. We will contact these responsible officers in a later phase.

What we need responsible officers to do

By Friday 14 September, we need responsible officers to submit a schedule for the doctors they will make recommendations about. They will do this using <u>GMC Connect</u> - a secure part of our website.

Between now and 14 September, we need responsible officers to:

- register for an account with GMC Connect and authorise access for any additional users
- using GMC Connect, check the list of doctors that we believe have a prescribed connection with their

designated body - we need responsible officers to do this by Friday 20 July

 develop and submit their schedules for making recommendations about doctors - we need responsible officers to do this by Friday 14 September.

In developing their schedules, responsible officers will need to take account of the implementation plan developed by their country (or region, if they are a responsible officer in England) and the <u>requirements we have recently published</u> that doctors must meet in order to have a recommendation made about them in the first cycle.

Resources and help

We have developed a <u>guide for responsible officers</u>, plus <u>a checklist</u>, which explains everything we need them to do by when. Links to these documents are included in the email that responsible officers will receive over the next few days. The documents can also be downloaded from <u>our website</u>.
