FREEDOM OF INFORMATION REQUEST: 12/1439

Your e-mail of 11 October made the following request:

"Please could I make a request for information under the freedom of information act. This repeats a previous request made from a different email account which I have not yet received an acknowledgment for. It may not have been sent. Please regard this if you have received it.

Please could you give me a list of applications to test for/explore/carry out other research activity into the existence of methane and shale gas by parliamentary constituency since 2008. This should include applications for licenses to carry out 'fracking'. If possible could you please give me the exact location the application would cover and, if available, any maps."

We have considered your request in accordance with the Environmental Information Regulations 2004 (EIRs) as the information you have sought disclosure of, does in our view, fall within the definition of 'environmental information' as set out in the EIRs.

Petroleum licences are not specific to shale gas and do not give permission for operations, but grant exclusivity to licensees in relation to petroleum exploration, appraisal and exploration within a particular licence area. Further consents from DECC are required for any drilling operation, or for production. We have taken your request to mean any applications received by DECC for gas exploration drilling consent since 2008. The list below indicates those drilling consent applications which have been received and the region in which the well sites are located. We do not have readily available relevant maps or a breakdown by constituency.



The following wells have been drilled since 2008 into prospective horizons for shale gas (Anna's road has not yet encountered the target Bowland Shale).

DECC has issued consent to drill the following wells for methane but drilling has not yet started.

The only well in which fracking for shale gas has been performed is Preese Hall (Cuadrilla).
