## 3. I would also like to know what percentage that have taken their practical Cat B test since 1st jan 1997 have gone onto take a B+E practical test

This is information that we do not currently produce and to compile this information would take in excess of 24 hours. This information is therefore exempt from release under section 12 (1) (cost of compliance exceeds appropriate limit) of the FoIA. A full breakdown of this exemption can be found at Annex B.

The appropriate limit, as prescribed by the Freedom of Information and Data Protection (Appropriate Limit and Fees) Regulations 2004, is £600 for Central Government and £450 for other public authorities, with staff costs calculated at a rate of £25 per hour. When calculating whether the appropriate limit is exceeded, authorities can take account of the costs of determining whether the information is held, locating and retrieving the information, and extracting the information from other documents. They cannot take account of the costs involved with considering whether information is exempt under the Act.

To compile the information would require us to extract details of all drivers (approximately 7 million records) who have taken and passed a category B test and this information is not

held prior to 2001 and is currently held on two data bases. We would then have to extract details of those who have passed a category B +E test and run a comparison exercise.
