## The interpretation of DNA evidence

A report on the interpretation of DNA evidence by Professor Peter Gill is published on the Regulator's website this month. It was prepared to advise him on the level of consensus in interpretation of DNA profiles and mixed profiles.

In preparing this report, Professor Peter Gill, an eminent research and development scientist / author in the field for forensic DNA, consulted nationally and internationally with stakeholders. The work was supported by scientists from my team in the Home Office Forensic Science Regulation Unit and DNA Analysis Specialist Group. As the report had a number of recommendations, the DNA Analysis Specialist Group were further tasked to incorporate the principles into the DNA appendix which the Regulator is publishing for consultation at the same time see below.

# Consultation on Appendices' to the Codes of Practice and Conduct

The Regulator set out his plan to produce a series of appendices on specific disciplines during the original consultation leading to the Codes of Practice and Conduct. The first three were written by the various specialist groups and sub-groups and are:

- Digital Forensic Services
- Digital Forensics: Video Analysis
- DNA Analysis

# Information document on legal obligations

It is essential that all those acting as expert witnesses within the Criminal Justice System are aware of the obligations pertaining to that role. The Regulator has therefore developed a paper considering the various obligations. It sets out an overview of the obligations placed on expert witnesses in the criminal justice system in England and Wales.

This document may also be useful for organizations conducting method development and validation as it could assist supplementing the intermediate user requirement with those of the end-user, the courts.

# Information document on forensic pathology code of practice

The Home Office published guidance on legal issues surrounding tissue handling and forensic pathology in 2006. This guidance has been reviewed and updated and primarily sets out a framework for the co-operation between those involved in the investigation of violent or suspicious death to ensure compliance with the various legal requirements relevant to such enquiries.

## **Lisbon Treaty**

On 15 October the Home Secretary announced in parliament that the government's current thinking is that "...we will opt out of all pre-Lisbon police and criminal justice measures and then negotiate with the Commission and other members states to opt back in to those individual measures which it is our national interest to rejoin". This gives a very clear signal that the government will seek to opt out of some 130 police and criminal justice measures but with no indication of those for which it would then negotiate to opt back in.

Within these measures is the Council Framework Decision 2009/905/JHA of 30 November 2009 on accreditation of forensic providers carrying out laboratory activities which mandates the accreditation of DNA and fingerprint laboratories. The final decision on opt out does not have to be made until May 2014 during which time the issues will be voted on in both houses of parliament and consulted with the European Affairs, Home Affairs and Justice Select Committees as well as the European Scrutiny Committee and the European Union Committee.

The Regulator has discussed the announcement with Chief Constable Chris Simms (ACPO lead on Forensic science) and DCC John Fletcher (ACPO lead on forensic science quality standards) and all agree that it should make no difference to police plans to achieve accreditation for police in-house laboratories. The police commitment and plans to achieving the Regulator's required quality standards for laboratory activities remain unaffected by the announcement and any subsequent decisions by the government regarding opt out.

# Science & Technology Committee hearing

The Science and Technology Commons Committee have announced their follow-up inquiry into the Forensic Science market following the closure of the Forensic Science Service. The Forensic Science Regulator has been invited to make a submission
