I write further to our response of 15 February 2013 to your earlier email of 18 January 2013 where you requested the following information:

I would like to request a list of all staff who have been seconded from outside organisations and are working on nuclear energy issues. For each person, I would like to request their:

- name
- job title
- the department they work in
- the company/organisation they have been seconded from (i.e. their employer)
- a brief job description
- the start and end dates of the secondment
- the amount the department is paying for them

I would like to limit my request from 1 January 2010 to the present day.

Freedom of Information Act 2000

Your request has been handled under the Freedom of Information Act 2000 ('the Act'). Under the Act you have the right to:

- know whether we hold the information you have requested and;
- be provided with that information (subject to any exemptions under the Act which may apply).

People working on nuclear energy issues

We explained in our earlier response that the records for those who have been seconded to DECC from outside organisations since 1 January 2010 and who have since left DECC, are not held centrally. The exercise to gather this information from individual policy areas has now concluded and the details that you have requested for these people are set out at Annex A.

In the our earlier response we provided the names of the people and an indication of the level of contribution that DECC was making for each person. In this response we have continued to provide similar information on the level of salary contribution but, having considered the case carefully, we have concluded that we should withhold the names of

those working at a level below that of SCS under section 40(2) of the Act as it is personal information.

In the case of our existing secondees a current contractual agreement is in place which allows us to disclose that information. However, for those who are no longer working in DECC and are of a more junior level, a current contractual agreement no longer exists.

Appeals procedure

If you are dissatisfied with the handling of your request, you have the right to ask for an internal review. Internal review requests should be submitted within two months of the date of receipt of the response to your original letter and should be addressed to the Security & Information Rights Unit (foi@decc.gsi.gov.uk).

- 1. Details of the amount DECC is paying for each secondee is exempt under section 40 (personal information) of the Act, as the information constitutes third party data. However, we have given an indication of the level of contribution DECC made to the salary costs of each secondee.
- 2. The names of those working at a level below that of SCS and who are no longer working in DECC are being withheld as it is exempt under section 40 (personal information) of the Act, as it is personal information.
- 3. Section 40(2) provides that personal data about third parties is exempt information if one of the conditions set out in section 40(3) is satisfied. Under the Act disclosure of this information would breach the fair processing principle contained in the Data Protection Act, where it would be unfair to that person/is confidential.
