I have spoken with. The ACPO representitive on Home Office Type Approval, Trevor Hall, about this issue. He advises that from your description the forward facing camera you refferred to is a dummy Gatso speed meter that is not subject of Home Office Type approval.

These units are used all over the UK and monitor traffic speeds in both directions. They are not used for enforcement hence no approval is reuired.

They operate is a similar way to a normal Gatso camera and fit in the same housings. The purpose for use is to provide a speed deterent effect and have been in use, continuously, since 1993.

If you provide the location of the site Trevor Hall will confirm this is the case in this instance with the local Police.

Picture a stretch of road with a rear facing GATSO on either side. While driving to an emergency using my blue lights I was exceeding the 40mph speed limit on a stretch of road with good visibility. Furthermore I was the only vehicle on that stretch of road at that time traveling in either direction. I was prepared for the camera that I passed to flash me from behind, which it duly did. However the rear facing camera on the other side of the carriageway also flashed me, which I wasn't expecting!

The flash in my face caused me momentarily to lose my vision. Had I been approaching a forward facing camera I would have been prepared and either slowed down or held a hand up to shield my eyes.

I understand that when a camera has no film in it, it can be reset to trigger at a lower speed or indeed to be triggered by

oncoming traffic. However I feel that this is a clear health and safety risk for people such as me who in the course of their work might have to trigger these cameras.

Is having a camera set to flash ONCOMING traffic without warning legal? And do I have a legitimate health and safety concern, bearing in mind the nature of my work and sometimes the speeds I am expected to drive at (obviously bearing in mind the road conditions!!) in order to meet our response time targets?
