The current breach rate for Antisocial Behaviour Orders in the Metropolitan Police district

Of the 1,160 Anti-Social Behaviour Orders issued in the Greater London Criminal Justice System Area between 1 June 2000 and 31 December 2005, 460 were proven in court to have been breached on at least one occasion during that period, corresponding to a breach rate of 40%.
