Summary

Registered medical practitioners are legally required to notify the Chief Medical Officer (CMO) of every abortion performed. The Department of Health receives these notifications on form HSA4 and undertakes the statistical processing and analysis. The Department of Health also process and publish abortion notifications on behalf of the Chief Medical Officer of Wales.

We have published an annual bulletin containing abortion statistics since 2002. Prior to 2002, this data was processed and published by the Office for National Statistics (ONS). In this bulletin, we present tables of abortion data for both residents and non-residents of England and Wales, with some information at Primary Care Trust (PCT) and Strategic Health Authority levels (Local Health board in Wales). The tables currently provide the abortion figures broken down by a range of variables: age, marital status, purchaser, statutory grounds, procedure, ethnicity, parity, complications, gestation period, medical conditions and country of residence for women not resident in England or Wales. The data are displayed as counts, percentages or rates. Similar publications for abortions carried out in Scotland are published by the Information Services Division, Scotland.

Under the Code of Practice for Official Statistics, we have an obligation to engage with users of these statistics to understand for what purposes they are used, and to improve their relevance and utility. We also have an obligation to consult with users over any proposed changes to the coverage of our statistics. Therefore, this consultation is aimed at all users of the abortion statistics bulletins to understand how these reports are used, to seek comments on how we should continue to maintain user engagement, and to ensure that they continue to meet user requirements. We are also seeking users' opinions specifically about the geographical breakdown of the statistics produced.

Under the health reforms, PCTs' responsibilities for the commissioning of abortion services will transfer to Clinical Commissioning Groups (CCGs) from 1 April 2013, whilst Local Authorities (LAs) will assume responsibility for the commissioning of other sexual health services (except for HIV treatment and care) and for many other public health services. PCTs and SHAs will cease to exist. We therefore anticipate an interest among users for information for CCGs and LAs and no longer a need for information for PCTs. Detailed figures cannot be released for CCGs, LAs and PCTs because of the risk of disclosure through differencing between figures for the two sets of geographical boundaries. We therefore propose to discontinue the production of information for PCTs and SHAs; and instead switch to presenting the data for CCGs, whilst additionally providing as much data at LA level as possible, given the need to avoid disclosure. We propose introducing the change for the next report, covering the year 2012, to support the analyses that users will be interested in carrying out relating to the new organisations.

The Abortion Statistics Bulletin has traditionally covered both England and Wales. We seek views on whether we should focus instead on England.

The overall aims of this consultation are to ensure that the reports remain as relevant and as useful to users as possible whilst maximising value for money. All responses received will be used to help the Department of Health to develop the Abortion Statistics Bulletin; however, they will need to be balanced against increasing resource pressures within the Department.

Background

National Statistics

Statisticians in the Department of Health aim to follow best practice when producing statistics. We want to collect the right data, process the data in a thorough way, and publish figures that are as useful as possible for everyone who wants to use them.

For all our statistical publications, we aim to follow the 'Code of Practice for Official Statistics'. Some of our figures are listed as 'National Statistics' and for those we must follow these rules. This ensures that our National Statistics meet the highest standards for statistical publications.

As part of our responsibilities under the Code of Practice, we want to work with people who use the figures to find out what they use them for and to make sure that publications are as useful as they can be. There is a value for money consideration too. We need to strike a balance between the figures that users want and the amount of resource needed to produce them.

We have a responsibility under these rules to consult users before making any changes that affect the National Statistics we publish. We are launching this consultation to ensure that these reports remain as relevant and useful as possible.

The Abortion Statistics Bulletin

This report is produced annually. The Department of Health has published this bulletin since 2002; prior to 2002, this data was processed and published by the Office for National Statistics (ONS). Reports for 2002 – 2011 can be found using the links below:

The bulletin provides tables of abortion data for residents of England and Wales and non-residents of England and Wales, with some information at Primary Care Trust and Strategic Health Authority levels (Local Health Board in Wales). The bulletin is reviewed each year and the detail in the publication has evolved based on policy developments, users' suggestions and frequently asked data requests. The tables currently provide the abortion figures broken down by a range of variables: age, marital status, purchaser, statutory grounds, procedure, ethnicity, parity, complications, gestation period, medical conditions and country of residence for women not resident in England and Wales. The data are displayed as counts, percentages or rates.

Where do we get the data from?

Registered medical practitioners are legally required to notify the Chief Medical Officer (CMO) of every abortion performed. The Department of Health receives these notifications on form HSA4 and undertakes the statistical processing and analysis. The Department of Health also process and publish abortion notifications on behalf of the Chief Medical Officer of Wales.

The Department of Health uses a thorough process for recording and monitoring information received on Abortion Notification form HSA4. Checks on the forms assist in monitoring the Abortion Act and ensuring that best practice guidance from the Department of Health is followed. The resulting data are used in the calculation of conception statistics by the ONS and are used to inform policy and to improve service provision, in areas such as teenage conceptions, rubella in pregnancy and reducing repeat abortions, for example.

The HSA4 forms contain sensitive personal data. All releases of abortion statistics outputs are subject to the disclosure controls. The data are published and released in accordance with the Department's responsibilities for providing information under the Freedom of Information Act, within the constraints of the Department's responsibilities for protecting personal data under the Data Protection Act.

Related statistics

Quarterly abortion statistics were published by the Office for National Statistics (ONS) in Table 4.2 of their Vital Statistics: Population and Health Reference Tables (formerly HSQ Reference Tables). The ONS reviewed all their reference tables and based on users views and the low number of 'hits' on the web page, decided to no longer publish Table 4.2. However, the Office for National Statistics still publish quarterly information in the Reference Tables on the percentage of conceptions terminated by abortion, as part of other information about conceptions.

Proposals

Annual report and user engagement

A statistical bulletin is published each year, typically in May or June. The bulletin provides tables of abortion data for residents of England and Wales and non-residents of England and Wales, with some information at Primary Care Organisation and Strategic Health Authority levels (Local Health Board in Wales). The tables provide the abortion figures broken down by a range of variables: age, marital status, purchaser, statutory grounds, procedure, ethnicity, parity, complications, gestation period, medical conditions and country of residence for women not resident in England and Wales.

Effective engagement with users is fundamental in deriving maximum value from the statistics. We seek feedback from users on their experiences of the statistical products and services through requests placed on the website and adhoc requests sent to the abortion statistics email. In addition, the Department has regular meetings with the Office of National Statistics, Welsh Government and Department for Education. Abortion issues are also regularly discussed at meetings with NHS colleagues and the Sexual Health Forum, which includes a range of stakeholder organisations including professional bodies, third sector, academic, educational, local government and special interest groups. We receive feedback from provider organisations, often opportunistically following discussions about data submissions.

Geography

Coverage of England and Wales

The abortion statistics publication largely contains totals for England and Wales, with only a few tables giving separate totals for England and Wales (and for health areas within England and Wales). Some Wales-only figures are published in the Health Statistics Wales annual publication (Welsh abortions statistics 2011). The publication of detailed totals for England and Wales limits what we can release for England, because publishing both would enable the deduction of disclosive information for Welsh residents through differencing. We are interested

in understanding whether users would find it more helpful if the Department's abortion statistics bulletin focused on England, with figures for Wales published separately.

As was done in the 2011 report, we would include some figures within the annual report for Great Britain to facilitate comparison, subject to support from the other administrations.

Present 2012 data by PCT, CCG or LA

Some of the tables within the annual report provide breakdowns by Primary Care Trust and Strategic Health Authority. Under the health reforms, PCTs and SHAs will cease to exist and PCTs' responsibilities for the commissioning of abortion services will transfer to Clinical Commissioning Groups (CCGs). We therefore anticipate a strong interest among users for information for CCGs and a reduction in interest for information for PCTs.

However, we also expect there to be significant demand for information for Local Authorities. LAs will assume responsibility for the commissioning of other sexual health services (except for HIV treatment and care) and for many other public health services. Additionally, there are plans to consult on the future commissioning of abortion services. Ideally, to meet all users' needs, we would present 2012 data by PCT, CCG and LA. However, detailed figures cannot be released for PCT, CCGs and LAs because of the risk of disclosure through differencing.

We therefore propose to discontinue the production of information for PCTs and SHAs; and instead switch to presenting the data for CCGs, as the commissioner of abortion services, whilst additionally providing as much data at LA level as possible, given the need to avoid disclosure. Once the primary geography breakdown is decided, this will apply to all abortion statistics outputs – the annual publication, adhoc data requests, parliamentary questions and FOI requests. We are therefore keen to hear from users about whether CCGs or LAs should be adopted as the primary breakdown.

Annex A provides analysis of CCG and LA boundary differencing and shows potential suppressions that would be applied.

We propose introducing the move away from PCTs for the next report, covering the year 2012. Whilst the new responsibilities were not in place in 2012, they are now and so the demand for

information relating to the new arrangements already exists. We would provide as much information as possible at CCG and LA level for previous years to facilitate comparisons over time. However, this would be limited by the fact that PCT information is already in the public domain for previous years, and full detail breakdowns cannot be released by PCT, CCG and LA. This would provide commissioners and other users with baseline data from which to plan and build a time series to monitor performance.

Annex A: Analysis of disclosure through differencing

Two different geographic boundaries – CCG and LA

If data are provided by both LAs and CCGs, their differing geographic boundaries will result in a distinct set of areas for which data can be derived. There are over 400 'determinable areas' and the size of their relevant populations (that is, females aged 15-44) range from less than 250 to over 100,000. Data for some of these areas – particularly the areas with populations at the lower end of the spectrum – would be disclosive.

For example, an LA may overlap two CCGs, with the majority of its residents in the first CCG and a small minority in a second CCG. The determinable area created by this overlap into the second CCG may have a small population. Correspondingly, the same issue may occur for CCGs that overlap with multiple LAs.

Mapping LAs and CCGs (as at Feb 2013) found that 13 determinable areas have female populations aged 15-44 of less than 1000. The risk of disclosure associated with abortion figures for populations below 1000 is such that their publication would constitute a breach of the Data Protection Act. Table A shows the determinable areas with the CCGs and LAs that they consist of.

If the recommendations in this consultation document are adopted, then we would publish total abortions for all LAs and CCGs with the exception of LAs that are constituent in determinable

areas with applicable populations of less than 1000. Data for these LAs would be suppressed. It may be necessary to carry out secondary suppression on other areas to prevent disclosure.

Table B extends this analysis and shows the restrictions that would be imposed on providing data for younger age groups. It shows the determinable areas that have female populations aged 13-15 of less than 1800. The risk of disclosure associated with abortion figures for these populations is such that their publication would constitute a breach of the Data Protection Act. 167 determinable areas have a female population aged 13-15 of less than 1800. These 167 areas comprise of 90 different CCGs and 139 different LAs. As above, data for these LAs would be suppressed, along with any others where secondary suppression is required. We would give consideration to reducing the degree of suppression required by offering figures for a wider age range.
