I am treating your correspondence as a request for information under the Freedom of Information Act 2000 (FOIA).

A search for the information has been completed within the UKHO, and I can confirm that all the information in scope of your request is held.

The UKHO use Blue Communication to distribute, manage and maintain a press contacts database. This contract is called off using the UKHO's Marketing Expertise Framework, in which Blue Communications are the supplier for Lot 6, PR and Media Relations which began on 08/11/2016 and runs until 31/10/2019 with an estimated allowance of up to £300,000 available spend on LOT 6.

2. The software used by the Media/Communications team to monitor the media. Please specify the value and length of any contracts associated with the tools you use.

3. The software used by the Media/Communications team to manage and store interactions with stakeholders (e.g. the media, regulators, government agencies, the community, the public). Please specify the value and length of any contracts associated with the tools you use.

The UKHO uses 'Precise Media who use Kantar Media to monitor media in which we receive daily alerts of any UKHO mentions in the press. We also use this to manage and store interactions with external Stakeholders. This contract runs from 11/01/2016 until 10/01/2019 and is valued at £54,900.

4. The software used by the Public Affairs or any other relevant team to monitor the political environment and Parliament and log interactions with politicians, civil servants, lobbying bodies, trade unions, etc. Please specify the value and length of any contracts associated with the tools you use.

We do not use any software to monitor public affairs. As a trading fund, our PR efforts are predominantly focussed on the commercial shipping market and global maritime trade press.
