Dear Colleague

There is a wealth of new policy developments and new publications covered in this month's bulletin. I would particularly like to draw your attention to two items which are particularly exciting in relation to future treatments for cancer.

First, there is last week's announcement about plans for new arrangements to commission and fund molecular tests for cancer. This issue was first flagged up in last year's cancer outcomes strategy and, with Andrew Lansley's announcement at the same time as the publication of the human genomics report, we are now ready to move forward on this.

Secondly, there is December's announcement in relation to proton beam therapy. Andrew Lansley has said that, subject to business case approval, the Government was ready to move forward with an investment of £150 million to enable the development of proton beam therapy services in this country.

I am also very pleased that, on Monday, we launched the first ever national bowel cancer symptom awareness campaign. But we must not forget the range of local symptom awareness campaigns that are also ongoing. In addition to those that have been funded locally, DH has funded a range of projects - which are just starting – to raise awareness of the symptom of "blood in urine" and of breast cancer symptoms in people over 70. Local campaigns in relation to oesophagogastric cancer are also being planned.

Finally, because of pressures on resources, we have decided to move to publishing this bulletin bi-monthly. The next edition will be published at the end of March 2012, and there will be approximately 5-6 editions per year.

£150 Million for Life Saving Cancer Treatment

On 13 December, Health Secretary, Andrew Lansley announced plans to invest in Proton Beam Radiotherapy at the Britain Against Cancer Conference subject to a business case. Approximately 1500 patients per year will benefit from the new National Proton Beam Therapy service. The new equipment will help children with cancer in particular and as the services develops it will help a wider range of cancer patient.

National Bowel Cancer Symptom Awareness Campaign launched on 30 January

The first NHS national bowel cancer public awareness campaign in England will launch on 30 January and run for 9 weeks until the end of March 2012. This campaign forms part of the Department of Health's plans to tackle England's poor cancer survival rates compared with Western European countries.

The campaign advertisements are featuring on TV, radio and other national media. There will also be face to face events taking place across England to promote the campaign messages with the public. The key message is that 'loose poo' and 'blood in poo' for more than three weeks can be symptoms of bowel cancer. Real GPs feature in the campaigns and encourage anyone with these symptoms to see their doctor early.

National Cancer Patient Experience Survey 2011/12

The questionnaire for the National Cancer Patient Experience Survey 2011/12 is being sent out from the end of January. The survey will be sent to cancer patients receiving treatment between September 2011 and November 2011 in all acute and specialist NHS trusts in England that provide adult acute cancer services. Recently admitted adult patients with a primary diagnosis of cancer will be included and all cancer types will be included.

Cancer Does Not Discriminate Launch

On Wednesday 7th December, the National Cancer Action Team (NCAT) launched its 'Cancer Does Not Discriminate' campaign. The campaign brings together several of NCAT's projects on raising cancer awareness in Black and Minority Ethnic (BME) communities.

The launch was held at the House of Commons and was hosted by David Lammy, MP for Tottenham. Other speakers included Diane Abbott, MP for Hackney North and Stoke Newington, Anjula Mutanda, celebrity psychologist, and Mike Richards.

Testing pathways of care for those living with and beyond cancer

Building on our Inheritance: Genomic Technology in Healthcare

On 25 January 2012, the Human Genomics Strategy Group published it report. In its report to Government, the Human Genomics Strategy Group, chaired by Professor Sir John Bell, highlights the UK's achievements in genetics research to date and proposes a strategic vision to realize the future benefit of genomics. It draws on expertise from across Government and research institutes and makes six recommendations to the Government.

The Government will respond to the recommendations in due course but, at the same time as the launch, Andrew Lansley announced that the NHS will take forward plans to improve the commissioning and funding arrangements for molecular tests for cancer patients. NICE Quality Standard: End of Life Care for Adults

NICE recently published a new quality standard for end of life care for adults. The quality standard provides 16 specific, concise quality statements, measures and audience descriptors to provide the public, health and social care professionals, commissioners and service providers with definitions of high-quality care. The statements are aspirational but achievable for adults nearing the end of life who are expected to die in the next 12 months. Cancer Survival by Cancer Network in England - Patients diagnosed 1996-2009 and followed up to 2010

On 13 December 2011, the Office for National Statistics released data for one and five year standardised cancer survival estimates for Cancer Networks. Key findings were that one-year and five-year survival rates for cancers of the oesophagus, stomach, colon, lung and breast(women) improved by 3 to15 per cent in 2009 compared to 1996. Regional disparity between the networks was fairly stable over the same period despite the large overall improvements in survival. For more information visit:

Index of Cancer Survival for Primary Care Trusts in England -Patients diagnosed 1996-2009 and followed up to 2010

On 13 December 2011, the Office for National Statistics released updated estimates of a cancer survival index at one year after diagnosis for all cancers combined in each of the 151 Primary Care Trusts (PCTs) in England, for patients diagnosed during 1996–2009 and followed up to 31 December 2010.

Some of the key findings were that, overall, the one-year cancer survival index for England has increased during the period 1996–2009, from 59.5 per cent for patients diagnosed in 1996 to 66.5 per cent in 2009. Geographic inequalities in cancer survival still persist but the clear North-South divide that existed in 1996 was

somewhat less marked in 2009. In 2009, the index of one-year net survival for all cancers combined remained on average 20% lower in elderly than in middle-aged patients. For more information visit: <u>Cancer Survival by PCT 1996 -2009</u>

National Cancer Peer Review Programme Report 2010-11

On 30 November 2011, the National Cancer Peer Review team published an overview of its findings from 2010/11. It focuses on compliance with specific measures included in the Manual for Cancer Services which supports quality assurance of cancer services and enables quality improvement and the implementation of NICE Improvement Outcomes Guidance. The report also identifies key themes nationally, and by tumour type, and confirms progress being made during 2009-2010 since the 2004 – 2008 peer review round. For more information visit:

On 13 December 2011 the first annual report on the *Improving Outcomes: A Strategy for Cancer* (Jan 2011) was published. The annual report highlights the progress that has been made so far, including improved data collection and analyses and campaigns to improve the public's awareness of cancer symptoms. The report also notes that there are still many challenges in terms of achieving the quality of cancer services and outcomes that the Strategy set out to deliver, including moving forward on piloting flexible sigmoidoscopy, a national awareness campaign on bowel cancer, and improving diagnostic capacity and productivity. Urgent GP referral rates for suspected cancer - NCIN Data Briefing

Late stage diagnosis is a significant contributing factor to the United Kingdom's poorer cancer survival rates. For England, estimates published in *Improving Outcomes: A Strategy for Cancer* suggested that if cancer patients were diagnosed

at the same early stage as in some other countries up to 10,000 deaths might be avoided annually.

This briefing provides updated information on the variation in the rates of urgent referrals for suspected cancer across England. These data can be used as a measure patient awareness, which may lead to an earlier diagnosis. For more information visit:

- how their disease category level expenditure is split across 12 care settings (2010-11 only); and

 how their expenditure distribution pattern compares with other commissioners nationally, locally or with similar characteristics.

Local Tobacco Control Profiles

On the 24 January 2012, the final version of the Local Tobacco Profiles for England were published. The work was led by the London Health Observatory (LHO) on behalf of the Public Health Observatories in England.

The tool brings together a set of indicators at both local authority and primary care trust level that are relevant to the major modern challenges of tobacco control in England. The tool gives local commissioners/services up-to-date information as well as indicator trends over time, where possible. This final release takes account of the user feedback received from the recent test version. In particular, the indicators relating to quitting smoking have been revised to reflect quitting as a proportion of the *smoking* population, rather than the total population. NHS Bowel Cancer Screening Programme: Piloting Flexible Sigmoidoscopy (Gateway 17127)

Flexible sigmoidoscopy (FS) is a complementary bowel screening methodology to the current faecal occult blood (FOB) test and could prevent around 3,000 cancers every year. Improving Outcomes: A Strategy for Cancer sets out how FS will be incorporated into the current bowel screening programme, with 60% coverage across England by the end of 2014-15. SHA clusters are invited to nominate FS pilot sites. Expressions of interest are required by 29 February 2012 and full bids by 30 March 2012.

Improving the Work Capability Assessment for Cancer Patients Consultation

DWP have launched a consultation on reforming the Work Capability Assessment (WCA) to ensure that cancer patients receive the support they need. The consultation is seeking views from interested stakeholders, particularly from individuals who have been or are being affected by cancer, their families and carers, healthcare practitioners and cancer specialists, and employers.

It aims to gather evidence about the effects of different cancer treatments and the range of debilitating effects they can cause. In addition, it seeks views and experiences about the importance and appropriateness of work for individuals who are being treated for or recovering from cancer.
