Active Known Issues

1.1

The ANY Tab

Information supplied from OFQUAL relating to Operational End and Certification End dates is not being reflected in the ANY model Last Date for New Starts and End Date respectively on LARA.

Investigation is underway to correct this error and the target resolution date is end of January. There is no work-round available for this error.

30th Jan Update – We are now in testing for the resolution for this problem.

31st Jan Update – Unfortunately the testing has revealed discrepancies in the data and work will need to be continued to fix the problem. We estimate that 17 to 20 thousand aims will be affected. A decision has been made to deploy any fixes to the bugs after February 6th.

18th Feb – after re- testing and coding a fix should be deployed into the system this week.

21st March – ANY tab issue's work In progress with an expected resolution date of mid April.

23rd May – Update on Any tab issue, we expect to resolve this query week beginning 28th May 2013.

10th July – ANY tab issue's is still in progress with an expected resolution date of end of July.

A note to Providers – if you are experiencing issues with your submission due to this problem please contact the Service Desk and the LARA team will update your records manually until a global solution can be applied.

Update from Agency regarding Stand Alone Qualifications Validity Start Date

In the Skills Funding Statement (2012) it was announced that certain stand alone health and safety, emergency first aid at work and food safety qualifications, along with fork lift truck qualifications, would be funded for new starts for those unemployed learners that are in receipt of Job Seekers Allowance (JSA)/Employment & Support Allowance (ESA) (Work Related Activity Group (WRAG)) from 1st January 2013.

The Agency is aware that a number of these qualifications are currently showing on LARA with an earlier start date than 1st January 2013. This is an error and we are working to rectify this. In the interim, please note that new starts are only eligible from 1st January 2013.

A list of the qualifications which currently hold an incorrect Validity Start Date can be found at the bottom of this document.

The LARA web page is currently displaying the Teaching Year as 2011/2012.

Can you please make sure that you alter the Teaching Year to display 2012/2013.

Investigation is underway to correct this error.

1.4

Incorrect data type found within the CSV file:- ENTRY_SUB_LEVEL_CODE table

Currently for levels 1/2, 2/3 and 1/2/3 are showing in the wrong format. This is currently displayed in either data type dd/mm/yyyy or mm/yy where it should be a level.

This problem will not be resolved until the new LARS application is available.

Standing Known Issues

1.1

Section 96 Approval End Date and 19 Plus Column

Early this year, DFE (Department for Education) will be working to change the field name 'Approval End Date' to 'Archive Date' on their data sheet for legal reasons, and look to remove column 19+. DFE will advise us when this is completed.

As we are in development for a new system no changes will be made to the current LARA 1.1 and the field name will remain titled as Approval End Date.

Resolved Known Issues

1.1

Duplicated on Framework Data

Duplicated Framework Data was present on the LARA downloads that went on to affect MI systems.

An Urgent request was approved and raised with our technical suppliers on the 5th December. The technical supplier deleted the data (15th January) and the amendments reflected in the download from the 17th January.

1.2

LARA MDB Downloads

The LARA DOWNLOADS web page publishes the data in 3 formats, one of which is Access. These particular downloads are not compacted before being zipped and uploaded onto the site and that this has caused frustration due to the lengthy extraction time.

We approached our technical supplier who advised that the issue was problematic and costly to resolve so have found a workaround in that the team will compact the files on site and upload them to another page – Misc Downloads. The most recently published data has been compacted and uploaded to this page.

Please note that the LARA team update data weekly and so providers should notice that the compacted download will reflect the date of the latest published changes. This is unlike the automated uploading on LARA Downloads which is daily regardless of change to the data.

Framework 501

Framework 501's aims did not display if a framework type with a pathway description of 1 or 2 was selected. This issue also delayed the regulated weekly publication of LARA updates.

A fix was deployed on the 30th January and the aims should now be visible. The delayed data will be published onto LARA for Monday 4th February.

1.4

Publication on LARA updates are on Hold

The Issue described relating to Framework 501 caused a delay in publication. The fix has been deployed into live and publication ran successfully. The LARA team will update the data on hold from Monday 28th January on the system. This set of data will therefore publish onto LARA for Monday 4th February.

1.5

Frameworks 501 and 455

There were further duplicated ID numbers produced by the system. In the short term 29 duplicated aims were worked on. The issue is now fixed. A permanent fix to duplication will be deployed in due course.

1.6

LARA Website Search – 18/02/2013 - 09:45 am

Error messages were appearing when using the search function. This was flagged with our technical supplier who maintains the website and downloads are now available.

1.8

Known issue with Section 96 (16-18 Apprenticeships)

Issue with Section 96 (16-18 Apprenticeships) was resolved at 15:00pm. Providers are now able to submit and validate learners through the Online Data Collections System.

1.9

ALR Funding Issue – Invalid SLN2 Value

A selection of Adult LR QCF aims which were displaying invalid SLN2 Values; this issue has now been resolved. Affected Aims list has now been removed.

1.10

QAA Data

QAA data reports are now being received correctly each month.

1.11

Framework - 494 and 548

Incorrect data has been supplied and loaded onto LARA and recalled by NAS. The FR number and AFO issue Number appear to be in the wrong fields. A request has been submitted to our technical supplier to delete this data.

23rd May – Issue now resolved the FR0 framework codes are no longer contained within the LARA.MDB file.

1.12

Issue with incorrect SSA Tier one codes on LARA

The LARA team are currently investigating, why there are over 6,000 learning aims currently displaying a NULL value instead of the correct SSA tier 1 code.

Issue now resolved and the LARA MDB file dated the 04/07/2013 contains all the missing data.

1.13

Validity Details Duplicated ID number 119807 against ASL funding stream for learning aim 50091104

A call has been raised to find out why the above issue has occurred to are technical team

A workaround will be to use the compacted LARA file which is available from the on LARA Misc Downloads page, which does not contain the validity error which was causing issues for providers MI systems and the LIS application.
