#### REQUEST FOR INFORMATION: COLEY PARK, READING

Thank you for your request for information about the use of Coley Park, Reading, which we received on 26 July 2013. As you know, we have handled your request under the Freedom of Information Act 2000 (FOIA).

In living memory, the site has been used as a Government office.

We understand the large chimney may have housed a chimney to a furnace in the laboratory in the annex below. We cannot confirm what the furnace would have been used for, as this would have been from a period around the 50s or 60s.

After the furnace was removed, the tower was used to house a water tank that served the site. We do not know when this was installed, but it was decommissioned and drained around 8-9 years ago.

In keeping with the spirit and effect of the FOIA, and in keeping with the government's Transparency Agenda, all information is assumed to be releasable to the public unless exempt. Therefore, the information released to you will now be published on <a href="www.gov.uk">www.gov.uk</a> together with any related information that will provide a key to its wider context. Please note that this will not include your personal data.
