Thank you for your email of 21 August 2013 where you requested the following information:

I am writing to request that you provide me with the following information under the Freedom of Information Act 2000.

### *Incoming secondments*

- 1. In the past 10 years:
- a) How many people have come to work at the department as a secondee from another department/organisation?
- b) Please give the start and end dates of each secondment (month and year will suffice. If they are still working at the department, please make that clear).
- c) For each secondee, please provide the name of the department or organisation where they usually work.
- d) Of these incoming secondments, is the worker paid by the department or their usual employer?

## **Outgoing secondments**

- 2. In the past 10 years:
- a) How many people from your department have been seconded to work at another department or organisation?
- b) Please give the start and end dates of each secondment (month and year will suffice. If the employee is still on secondment, please make that clear).
- c) For each secondee, please give the name of the department or organisation they were seconded to.
- d) Of these outgoing secondments, is the worker paid by the department or their temporary employer?

## Freedom of Information Act 2000

Your request has been handled under the Freedom of Information Act 2000 ('the Act'). Under the Act you have the right to:

- know whether we hold the information you have requested; and
- be provided with that information (subject to any exemptions under the Act which may apply).

The Department of Energy and Climate Change (DECC) was created in October 2008, to bring together energy policy (previously with BERR, which is now BIS - the Department for Business, Innovation and Skills), and climate change mitigation policy (previously with DEFRA - the Department for Environment, Food and Rural Affairs). Therefore no records exist prior to that date.

From October 2008 until October 2010 the Secondment HR records were held by local managers and outline details were maintained under two legacy Shared Service providers. Those records were maintained in different formats and to differing standards. They have now been combined but data prior to November 2010 may not be fully complete.

### Staff seconded into DECC

From the data that we hold, a total of 123 people have been on secondments from organisations outside of DECC. The details of those secondments that you have requested are shown in <a href="Appendix A">Appendix A</a>. Where people are seconded into DECC they will remain on the payroll of the host organisation and any costs agreed in the individual secondment agreement will be recovered from DECC by invoice.

#### Staff seconded out of DECC

From the data that we hold, a total of 37 people have gone on secondment to organisations outside of DECC. The details of those secondments that you have requested are shown in <a href="Appendix B">Appendix B</a>. Where people are seconded out of DECC they will normally remain on the DECC payroll and any costs agreed in the individual secondment agreement will recovered by DECC through an invoice.

Where people have been seconded into or out of DECC from organisations of less than 10 people the name of the organisation has been redacted as this could lead to the identification of the individual. Section 40(2) provides an absolute exemption for personal data which then falls to be dealt with under the Data Protection Act. Personal data of third parties can only be disclosed in accordance with the data protection principles. In particular, the first data protection principle requires that disclosure must be fair and lawful and must comply with one of the conditions in Schedule 2 of the Data Protection Act. We do not think that it is fair to release information which could result in individuals being identified and do not think that any of the relevant conditions apply.

Finally we can neither confirm nor deny that DECC holds any information relating to secondments from the security bodies listed in section 23(3), as the duty to comply with section 1(1)(a) of the Act does not apply by virtue of section 23(5). Section 23(5) is an absolute exemption and no public interest consideration is required.

## Appeals procedure

If you are dissatisfied with the handling of your request, you have the right to ask for an internal review. Internal review requests should be submitted within two months of the date of receipt of the response to your original letter and should be addressed to the Information Rights Unit (foi@decc.gsi.gov.uk).
