**REQUEST FOR INFORMATION:** Defra spend on contractors

Thank you for your request for information about Defra's spend on contractors, which we received on 23 January. We have considered your request under the Freedom of Information Act 2000 (FOIA).

**You asked:**

Please could you provide me with data on how much DEFRA spent on contractors (in total) in 2012. Please note that I am interested specifically on expenditure on contracted services, not total expenditure on third parties in general.

**In response:**

It is usual for Government Departments to report expenditure on a financial year (April to March) rather than a calendar year basis. Defra's expenditure on contractors is published annually in the Department's Annual Report and Accounts (ARA). The 2012/13 ARA can be found at the following link:
