Staff in Post by Job Group

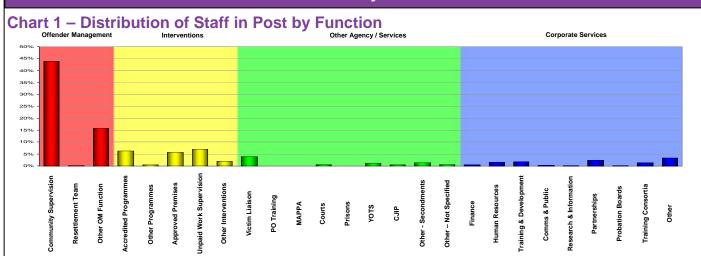
Table 1 – Staff in Post by Job Group

- On 31st December 2013 there was a total of 16,235.77 FTE staff employed and funded by the Probation Service (including Chief Executives); a decrease of 64.22 FTE on the figure at the end of Quarter 2 2013/14 (down 0.39%).
- When compared to Quarter 2 2013/14, 5 of the 15 job groups have shown an increase in staff in post, whilst 8 groups have decreased. The Chief Executive and Psychologist job groups remained the same.
- The largest increases were in the Other Operational Staff job group; increasing by 37.19 FTE (up 3.76%), and the Support Staff - Administration job group, which increased by 15.42 FTE (up 0.45%).
- The largest decrease was in the Probation Officer job group; decreasing by 54.27 FTE (down 1.23%). The next largest decrease came in the Other Staff job group which fell by 28.36 FTE (down 10.00%).
- The percentage of staff working in an offender related function at the end of Q3 was 88.82% (14,420.79 FTE), with 11.12% of staff working in Corporate Services (1,805.21 FTE). Those with a not recorded function accounted for 0.06% (9.77 FTE).
- The ratio of staff in offender services to corporate services was 7.99:1, up from 7.90:1 in Q2 13/14.
- The ratio of Probation Officers to Probation Services Officers was 1.02:1, down from 1.03:1 when compared to the previous guarter.
- The ratio of non-management to management staff was 8.62:1, up from 8.61:1 in the last quarter.
- Staff working in management roles accounted for 10.40% of the total workforce (1,687.93 FTE), which remained the same in percentage terms when compared to Q2; 89.60% of staff were in a non-management role (14,547.84 FTE), which also remained the same in percentage terms when compared to Q2.

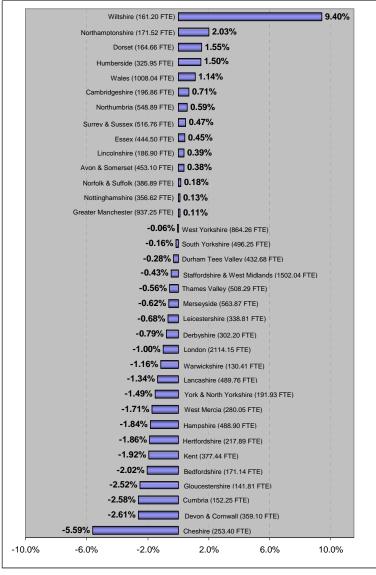
Staff in Post by Function



- The job group with the largest number of staff working in an 'Offender Management' function in Quarter 3 2013/14 was the Probation Officer group with 3,733.62 FTE (85.65% of the group).
- The Probation Services Officer job group had the largest number of staff working in an 'Interventions' function with 1,452.39 FTE (33.93% of the group).
- The Probation Services Officer job group also had the largest number working in an 'Other Agency/Services' function with 437.21 FTE (10.21% of the group).
- The Support Staff Other job group had the largest number of staff working in a 'Corporate Services' function with 544.46 FTE (74.58% of the group).
- London region had the largest number of staff working in an 'Offender Management' function (1,487.99 FTE); whereas North West region had the largest number in an 'Interventions' function (531.08 FTE); West Midlands region had the largest number in an 'Other Agency/Services' function (216.39 FTE) and South East region had the largest number in a 'Corporate Services' function (241.18 FTE).

Chart 2 - Change in Staff in Post by Trust



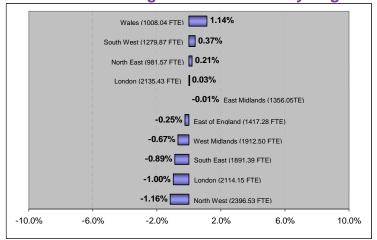

- At the end of Quarter 3 2013/14, 21 of the 35 probation trusts reported a decrease in staff from the previous quarter (60%); whilst 14 reported an increase (40%).
- Cheshire reported the largest decrease in percentage terms when compared to the previous quarter, with a fall of 5.59% (15.00 FTE). The next largest decrease was in Devon & Cornwall with a fall of 2.61% (9.62 FTE) respectively; followed by Cumbria who saw a fall of 2.58% (4.04 FTE).
- The largest quarterly FTE fall came in London, with a drop of 21.28 FTE (1.00%); followed by Cheshire and Devon & Cornwall, with falls of 15.00 FTE (5.59%) and 9.62 FTE (2.61%) respectively.
- Wiltshire and Northamptonshire reported the largest quarterly increases in percentage terms with increases of 9.40% (13.85 FTE) and 2.03% (3.42 FTE) respectively; followed by Dorset who saw an increase of 1.55% (2.52 FTE).
- The largest quarterly FTE increase came in Wiltshire, with a rise of 13.85 FTE (9.40%); followed by Wales, with an increase of 11.36 FTE (1.14%). Following these, Humberside was next with a rise of 4.82 FTE (1.50%).

- At the end of Quarter 3 2013/14, 6 of the 10 probation regions reported a decrease in staff from the previous quarter (60%); whilst 4 reported an increase (40%).
- North West region reported the largest decreases in both percentage and FTE terms when compared to the previous quarter, with falls of 1.16% and 28.14 FTE respectively.
 The next largest decreases were in London region with falls of 1.00% and 21.28 FTE.
- Wales and South West regions reported the largest quarterly increases in percentage terms with increases of 1.14% (11.36 FTE) and 0.37% (4.78 FTE) respectively.
- The largest quarterly FTE increase came in Wales region, with a rise of 11.36 FTE (1.14%); followed by South West region, with an increase of 4.78 FTE (0.37%).

- At the end of Q3 2013/14, 6.22% of staff employed by the Probation Service were funded by external organisations (1,077.55 FTE).
- The largest group of staff employed by the probation trusts but funded by external organisations were those funded by HMPS; accounting for 575.99 FTE.
