
The Merchant Shipping (Cargo Ship Construction) Regulations 1997: Schedules

Notice to Shipowners, Shipbuilders, Masters, Certifying Authorities and Surveyors

Due to the unforeseen delay in publication of United Kingdom legislation which is referred to in Merchant Shipping Notice MSN 1671 (M), the following amendments to the text of MSN 1671 (M) have been made as an interim measure.

- 1) Schedule 2 - Paragraphs 5 & 6 - For Merchant Shipping (Fire Protection: Large Ships) Regulations 1997 read the Merchant Shipping (Fire Appliances) Regulations 1980 (as amended) or the Merchant Shipping (Fire Protection) Regulations 1984 (as amended) as appropriate.
- 2) Schedule 10 - Part 1 - Paragraph 1 (a) (i) - For Merchant Shipping (Life Saving Appliances for ships other than ships of Classes III to VI(A)) Regulations 1997 read the Merchant Shipping (Life-Saving Appliances) Regulations 1980 (as amended).
- 3) Schedule 10 - Part 3 - Paragraph 3 (b) (i) (aa) - For Merchant Shipping (Life Saving Appliances for ships other than ships of Classes III to VI(A)) Regulations 1997 read the Merchant Shipping (Life-Saving Appliances) Regulations 1980 (as amended).
- 4) Schedule 10 - Part 3 - Paragraph 3 (b) (i) (bb) - For Merchant Shipping (Life Saving Appliances for ships other than ships of Classes III to VI(A)) Regulations 1997 read the Merchant Shipping (Life-Saving Appliances) Regulations 1986 (as amended).
- 5) Schedule 10 - Part 3 - Paragraph 3 (b) (iv) (bb) - For Merchant Shipping (Fire Protection: Large Ships) Regulations 1997 read the Merchant Shipping (Fire Protection) Regulations 1984 (as amended).

Upon the entering into force of the Merchant Shipping (Fire Protection: Large Ships) Regulations 1997 paragraphs 1 and 5 of this amendment will cease to apply.

Upon the entering into force of the Merchant Shipping (Life Saving Appliances for ships other than ships of Classes III to VI(A)) Regulations 1997, paragraphs 2,3 and 4 of this amendment will cease to apply.
