Exchange of information - Rapid Information System (RAPEX): it was initially established under [Directive 2001/95/EC on General product safety \(GPSD\)](#) for consumer goods and its scope was subsequently extended by [Regulation \(EC\) 765/2008](#) to include all harmonized goods. Thus, since 1 January 2010 it has been used to notify serious risks presented by consumer and professional products.
