# REQUEST FOR INFORMATION: Meetings between Defra and the ABI, BIBA and other insurance related organisations

Thank you for your revised email request for information about the dates and locations of meetings since January 2012 between Defra and the following organisations: the Association of British Insurers, the British Insurance Brokers Association, Lloyd's market insurers, insurance companies, insurance brokers and any other insurance-related companies to discuss the future of flood insurance following the expiry of the current Statement of Principles. Your revised email request was received on 12 June 2013. As you know, we have handled your request under the Freedom of Information Act 2000 (FOIA).

**Table 1** provides the dates and locations of the 60 meetings between Defra and the ABI.

**Table 2** provides the dates and locations of the 2 meetings between Defra and BIBA.

**Table 3** provides the dates and locations of the 10 meetings between Defra and insurance companies, insurance brokers and any other insurance-related companies. No meetings with Lloyd's market insurers have been recorded.

The list supplied reflects our best available information. However, there may be gaps, for example where team members have left Defra, as it has not been possible to access their records for inclusion in your request.
