#### Introduction

This Statistical Notice presents information on the activity of the Social Security and Child Support (SSCS) tribunal for the period, 1 April 2011 to 31 May 2011.

I have taken the decision to release this information outside the usual timetable for Statistical Releases due to the amount of Parliamentary and media interest in the work of SSCS over recent months and to ensure that debate is informed by the latest data. It should be noted that information is provisional management information and may be amended when Official Statistics are published. This notice will be published monthly until the end of August 2011 when we will review the need for monthly publication. This is the fifth of such reports and they have been published at http://www.justice.gov.uk/publications/statistics-and-data/tribunals/sscs-stats.htm.

# Key Findings<sup>1</sup>

Social Security and Child Support (SSCS) had 56,900 receipts between 1 April 2011 and 31 May 2011, a decrease of 8% compared to the same period last year (61,700), but 50% higher than for the same period in 2009 (38,100). There has been a 37% increase in the number of disposals by this jurisdiction from 50,500 in the year to date to 31 May 2010, to 69,000 in the year to date to 31 May 2011. When compared with same period of the previous year, there were 71% more disposals in 1 April 2011 to 31 May 2011.

#### **Receipts and Disposals**

- Receipts in May 2011 (29,100) were 4% lower than May 2010, but 44% higher than May 2009.
- The level of disposals has remained high, with 35,700 in May 2011 the second highest recorded.
- In May 2011, the number of disposals exceeded receipts for the fifth consecutive month.
- For Employment Support Allowance (ESA) and Incapacity Benefit (IB) specifically:
  - The number of ESA/IB receipts in May 2011 (14,700) was at the lowest level since August 2009.
  - After a peak of 23,100 disposals in March 2011, disposals in April 2011 (18,900) and May 2011 (20,100) returned to similar levels to those in the previous six months.
  - ESA/IB disposals outstripped receipts in May 2011 for the seventh consecutive month.

#### **Caseload Outstanding**

- At 31 May, 2011, the caseload outstanding was 183,400, a decrease of 3% on the number at 30 April 2011. This has decreased in three of the last four months. However, it is still 20% higher than at 31 May 2010 and 177% higher than the 66,300 outstanding at 31 May 2009.
- For ESA and IB cases, disposals have exceeded receipts for the last seven months and the number outstanding has started to fall.

#### **Clearances and Timeliness**

• The average clearance time (from receipt to disposal) has been increasing over the last couple of years. In May 2011, this average was 24.1 weeks compared with 17.2 weeks in May 2010.

## Commentary

#### Receipts and Disposals (Tables 1.1 and 2.1)

1. The Social Security and Child Support (SSCS) tribunal had 56,900 receipts in the period 1 April 2011 to 31 May 2011 – more than half of all receipts received by Tribunals. Receipts to SSCS have been increasing over the last couple of years, with peaks of 40,100 in August 2010 and 40,200 in March 2011. However, the level of receipts has varied since August 2010 and the 56,900 receipts in the period 1 April 2011 to 31 May 2011 are 8% lower than in the same period of 2010-11 (61,700). They are still 50% higher than the same period in 2009 (38,100).

2. The number of receipts in May 2011 (29,100) was 4% lower than May 2010, but 44% higher than May 2009.




Figure 1: Receipts and Disposals from April 2008 to May 2011

3. Between 1 April 2011 and 31 May 2011, SSCS disposed of 69,000 cases – an increase of 37% on the number disposed of in the same period in 2010, and 71% on the number in 2009.

4. **Figure 1** shows the trend in both receipts and disposals. The number of disposals has generally been rising since December 2009. The number of disposals in May 2011 (at 35,700) was the second highest recorded and exceeded receipts for the fifth consecutive month. In that month there were 35,700 disposals as compared with 29,100 receipts.

#### Receipts and Disposals by Benefit Type (Tables 1.1 and 2.1)

5. Of those 56,900 cases received between 1 April 2011 and 31 May 2011:

- 29,900 or 52% related to Employment Support Allowance (ESA)/Incapacity Benefit (IB);
- 11,600 or 20% were for Disability Living Allowance/Attendance Allowance (DLA/AA);
- 8,100 or 14% were for Job Seeker's Allowance (JSA).

6. The rise in SSCS receipts over recent years has mainly been caused by the introduction of Employment Support Allowance in October 2008 to replace Incapacity Benefit. In the period 1 April 2011 to 31 May 2011, SSCS had 29,900 receipts for these two benefit types – 16% lower than the same period last year, but more than double those received in the year to date to 31 May 2009. Individually, receipts in Employment Support Allowance fell by 8% compared with 1 April 2010 to 31 May 2010, whilst receipts for Incapacity Benefit fell by 53% over the same period.

7. Sizeable monthly increases in ESA/IB receipts were seen from June 2009 when receipts were 10,200, and the number generally continued to rise until August 2010, when ESA/IB receipts reached a peak of 23,600. Since August 2010, the number of ESA/IB receipts fell each month until December 2010. After a rise between January and March 2011, receipts for May 2011 have again fallen. There were 14,700 ESA/IB receipts in May 2011 - the lowest since August 2009.

8. Examining the other benefit types, the majority saw a fall in the number of receipts when comparing the period 1 April 2011 to 31 May 2011 with the same period in 2010. There were however, increases in the number of receipts for Job Seeker's Allowance (JSA), Carers Allowance and Pensions Credits.

Between 1 April-31 May 2010 and 1 April-31 May 2011:

- Income Support fell by 35%, from 2,600 to 1,700
- Industrial Injuries Disablement Benefit (IIDB) fell by 45%, from 1,700 to 940
- Disability Living Allowance/Attendance Allowance remained at the same level (11,600) for both periods
- JSA receipts increased by 50% to 8,100
- Pensions Credit receipts increased by 69%,to 360, and
- Carers Allowance receipts increased by 55% to 310.

9. In the period 1 April 2011 to 31 May 2011, 39,000 ESA/IB cases were disposed of – 56% of all SSCS disposals for that period. This is 37% greater than the number in April to May 2010 and 175% higher than the number of in the same period in 2009.

10. Similarly to receipts, the number of ESA/IB disposals has been generally increasing since June 2009. After a peak of 23,100 disposals in March 2011, disposals in April 2011 (18,900) and May 2011 (20,100) returned to similar levels to those in the previous six months. The number of ESA/IB disposals has outstripped receipts for each of the past seven consecutive months.




Figure 2: ESA/IB Receipts and Disposals from April 2008 to May 2011

#### **Outcome of hearings (Table 2.2)**

11. Table 2.2 provides some information on the outcome of Social Security and Child Support cases that were cleared at hearing<sup>2</sup>, and whether the decision was found in favour of the appellant or if the original decision made by DWP was upheld. In the period 1 April to 31 May 2011, there were 53,000 hearing clearances. Of these, 35% were found in favour of the appellant (but there is some variation in that proportion by benefit type:

- 39% of DLA/AA in favour of the appellant;
- 40% of ESA/IB;




- 15% of JSA;
- 28% of Income Support; and,
- 8% of Social Fund.

#### Caseload Outstanding (Table 3.1)

12. At 31 May, 2011, the caseload outstanding was 183,400, a decrease of 3% on the number at 30 April 2011. Although this is the third decrease in the last four months, it is still 20% higher than at 31 May 2010 and 177% higher than the 66,300 outstanding at 31 May 2009. Over half of the outstanding caseload is ESA and IB cases. Examining just the "04 Tribunal Category", which is where ESA and IB cases are predominately recorded, the outstanding caseload was 87,900 at 31 May 2011 (as compared with 95,500 in April 2011 and 82,200 at 31 May 2010).

13. Figure 3 shows significant rises in the caseload outstanding (for the "04 Tribunal Category/ ESA/IB") around the time that receipts of ESA/IB started to increase. As disposals have exceeded receipts for the last seven consecutive months, the numbers outstanding have started to fall.







#### Timeliness

14. A measure of timeliness has been examined showing the average amount of time (in weeks) taken from receipt at the tribunal to clear or dispose of a case. Figure 4 shows that the average clearance time has been increasing over the last couple of years. In May 2011, this average was 24.1 weeks for all benefits combined and 24.9 for ESA/IB cases. Individually, the average clearance time for ESA cases was 24.5 weeks, IB cases 27.3 weeks, DLA 28.2 weeks and JSA cases 14.1 weeks for May 2011.

## **Explanatory notes**

#### Data quality and sources

Information presented in this report is drawn from administrative sources. It should be noted that some information contained in this notice is provisional management information and may be amended when Official Statistics are published.

#### Definitions

**Receipt** – Volumetric term covering the acceptance of a case within the Tribunals Service.

**Disposal** – A disposal is the closure of a case when work has ceased to be done. This can be through a claim being withdrawn, settled, dismissed or being heard at a hearing.

**Hearing clearance** – these are cleared via a Tribunal (could be a panel or member of the Judiciary sitting alone) with a decision/outcome.

**Non-hearing clearance** – these are cases withdrawn prior to a hearing, struck out or superseded. There are some Tribunal judgements (some go the judge who decides that they should be struck out).

**Hearing** – The hearing is a meeting at which the tribunal panel considers evidence (either orally or paper based) and reaches a decision (where the decision may be to adjourn or to agree a final outcome). If the hearing is adjourned and restarted, it counts as one hearing.

Examples of hearings include:

- Paper hearings;
- Oral hearings;
- Case Management Discussions;
- Decision on Eligibility.

**Oral Hearing** – A hearing where the party(ies) and/or their representative(s) have been invited to attend (this can be by telephone or by video conference).

**Paper Hearing** – Consideration of the case using documents, and not requiring any physical appearance by the parties.

**Decision in favour** – Decision in favour of the appellant.

**Decision upheld** – Decision made by the First Tier Agency (Department of Work and Pensions) upheld by the Tribunal.

**Withdrawal** – The applicant/claimant/appellant ceases action either before or at the hearing.

**Settlement** – Cases settled without the need for a hearing. A third party may have been involved in the process.

**Outcome of hearing** – The outcome of the hearing is the final determination of the proceedings or of a particular issue in those proceedings.

**Caseload outstanding** – The number of cases outstanding at the end of the period and still waiting to be dealt with to completion.
