REQUEST FOR INFORMATION: MINISTERIAL TELEVISION TRAINING

Thank you for your request for information about Ministerial television training in Defra, which we received on 9 September. As you know, we have handled your request under the Freedom of Information Act 2000 (FOIA).

You asked:

"How much money have you spent on ministerial television training since May 2010? Who received this training? What kind of training did they receive? Who conducted the training?"

The information you requested is as follows:

There has been no money spent on ministerial television training since May 2010.

The supplementary questions in this FoI are therefore not applicable as they relate to paidfor television training, of which there has been none.
