Introduction

Following the April 2013 changes to the healthcare system, it is no longer appropriate for the Department of Health to report on the performance and financial outturns of the NHS, and there will be no further editions of *The Quarter*.

Much of the data that would have been reported in *The Quarter* for quarter 4 (Q4) 2012/13 has already been published, and the purpose of this document is to bring together the details of where this information may be found.

However, where performance data for Q4 2012/13 has not yet been published elsewhere, it is provided in this document (Annexes A and B). This data is the financial performance of NHS organisations, and quality, innovation, productivity and prevention (QIPP) efficiency savings.

Earlier editions of *The Quarter* have published NHS Performance Framework results and Tripartite Formal Agreement (TFA) ratings for NHS Trusts. The Performance Framework set out how the Department of Health identified underperforming NHS organisations and when intervention by SHAs and PCTs was appropriate. Performance management of the NHS has been managed by new organisations since April 2013, and we have decided that it would be impractical to produce and inappropriate to publish the results for the last quarter of 2012/13.


Figure 1 NHS Financial Performance by SHA area - PCT/SHA sector



Patient Choice

In 2012/13, three separate measures were used to assess whether choice is being offered by referrers, using the Choose and Book system, to refer patients for first consultant outpatient services.

Proportion of GP referrals to first outpatient appointments booked using Choose and Book

The overall Choose and Book utilisation rate was 51 percent in March 2013, based on outturn GP referrals to first outpatient appointments, which was slightly higher than the February figure of 50 percent.

Bookings to services where named consultant-led teams were available

March 2013 data indicates the percentage of secondary care first outpatient bookings made through Choose and Book to services where named clinicians are available, even if not selected, has remained stable at 81 percent at the end of Q4 2012/13.

Patients treated at non-NHS hospitals

Figures for March 2013 show 7.9% of patients were referred to a first outpatient appointment at non-NHS provided services. These are considered to have exercised choice, since it is likely that an alternative NHS provider was also offered to them.
