


**Average of independent forecasts for 2012; GDP growth,  
CPI and RPI inflation and claimant unemployment**




**Average of independent forecasts for 2012; Current account and PSNB (2012-13)**




**Average of independent forecasts for 2013; GDP growth,  
CPI and RPI inflation and claimant unemployment**




**Average of independent forecasts for 2013; Current account and PSNB (2013-14)**




**Dispersion around the independent consensus for 2012;

months**




**Dispersion around the independent consensus for 2012;
