Thank you for your e-mail of 29 August 2013 requesting information on the energy efficiency of public buildings in the UK.

We have considered your request in accordance with the Environmental Information Regulations 2004 (EIRs) as the information you have sought disclosure of, does in our view, fall within the definition of 'environmental information' as stated in the EIRs. The Department of Energy and Climate Change (DECC) does not hold information on Energy Performance Certificates (EPCs), carbon emissions or energy costs for all public buildings in the UK. However, DECC does hold information on Display Energy Certificates (DECs) relating to buildings for which it is responsible and on its own carbon emissions and energy costs.

DECC does not hold information on EPCs for any of its buildings in England. However, EPC/DEC data is publicly available from the keeper of EPC register, Landmark Group (<u>EPCData@landmark.co.uk</u>) and is available as one of 3 standard data packs. Further information can be found at:

You should contact Landmark directly for further advice on what data and format it is available in and also the cost of meeting your request.

The tables below show energy costs, carbon emissions and DEC ratings for 3 Whitehall Place and 55 Whitehall, for the past three financial years. We do not hold information on energy costs for 55 Whitehall prior to DECC taking over the building in April 2011. Information is also included on DECC's share of energy costs and emissions relating to its office at Atholl House in Aberdeen. This building is shared with other tenants. There is no requirement for DECs in public buildings in Scotland although there is a similar requirement regarding Energy Performance Certificates (EPC). The EPC ratings for Atholl House are shown in table 3.
